#### **COUNCIL ANNOUNCEMENTS**

Indigenous Peoples Day. Councilmember Studley quoted the First Amendment of the Constitution and recognized Indigenous People's Day, which was October 10th, and said the month of October is LGBTQ+ History Month. She read an excerpt from *Latter Gay Stories*. She has received many comments about statements made in multiple private events and she wanted everyone to know she shared their frustration. She said everyone knows she feels strongly about her actions matching her words. She said it is one of the primary responsibilities of City Council to use this special and important platform entrusted to Council by the voters in order to speak for those who do not have a voice.

Councilmember Schueler encouraged everyone to look online where there is a Crowd Source document highlighting all of the indigenous land around the world. She said this resource allows people to see where each indigenous tribe resides.

Councilmember Grant said she is enjoying the freedom to express her dissatisfaction publicly with an increasing abnormal status quo. She said there is a time and place for making others uncomfortable and she knows the time for causing discomfort comes when she, a brown person, with a whole history that will not be whitewashed out of narcissistic displays of nationalism. She said patriotism is an adherence to the ideals of the United States and nationalism is loyalty to the in-group versus acting in the interest of the entire country. She realizes that her time on Council will be met with obstruction and bad faith actors who long for the days of the Sundown Town, which is to say that you can change a street name a lot faster than you can overhaul the culture that created a DeBarr Avenue a/k/a Deans Row in the first place. She said many have given up their first amendment right to serve this country; however, she has chosen to define her career choices in public service with words and action.

Councilmember Holman said Indigenous People's day is a part of Oklahoma and United States history. He said Norman has quite a bit of history with tribes located in the area. He urged people to visit Jacobson House, which is open to the public and houses a lot of Native American history.

<u>Benefit Nights at the Garage Restaurant</u>. Councilmember Schueler said tonight there is a benefit for Norman Pride from 6-9 p.m. and next Wednesday, October 19th, will be a benefit for Norman CARE-A-VANS from 6-9 p.m.

<u>Fall Cleanup</u>. Councilmember Schueler said Saturday, October 15th, is Fall Cleanup for most of Ward 2. She reminded residents to put out all of their unwanted large items at the curb.

Councilmember Foreman said most of Ward 6 will have Fall Cleanup on Saturday, October 29th. She thanked the City for providing this service.

Councilmember Holman said most of Ward 7 will have Fall Cleanup on Saturday, October 22.

<u>International Festival</u>. Councilmember Schueler said she is excited about the upcoming International Festival on Sunday, October 23rd at Reaves Park.

Councilmember Holman said the international diversity in Norman is one of the earliest memories of growing up in the public school system full of students with a wide range of diversity.

<u>Ward Boundary Changes</u>. Councilmember Schueler said on September 13th, Council adopted the Ordinance changing the ward boundaries and that Ordinance goes into effect on October 13th. She urged residents to check the new boundaries to see if their ward is different.

Councilmember Foreman said she posted the new ward boundaries on her Facebook Page. She asked Council to share their new ward boundaries with their constituents.

Councilmember Holman said Ward 7 will lose several residents to Ward 4 and Ward 1. He said he plans to post the map to his Facebook Page.

<u>Code Compliance Month/Action Center</u>. Councilmember Schueler said 10,000 code cases annually is a lot and felt the Code Compliance Officers should be recognized for all the things they do to address these cases. She reminded everyone to contact the Action Center when there is a problem and they are unsure of who to contact. She said the Action Center phone number is 405-366-5396 and the email address is action.center@normanok.gov.

<u>Voter Registration</u>. Councilmember Schueler said the voter registration deadline for the upcoming mid-term election in November is Friday, October 14.

Councilmembers Lynn and Holman encouraged people to register to vote or update their registration.

Red Dirt Collective. Councilmember Schueler said Red Dirt Collective is sponsoring a Mutual Aid Fair in November, requesting donations, and asking for those who are interested to reach out to them on Facebook.

<u>Columbus Day</u>. Councilmember Lynn said he had a great Columbus Day and hoped everyone had a good one also.

Affordable Housing Town Hall. Councilmember Grant said there is an Affordable Housing Town Hall Meeting at City Hall on Tuesday, October 19th, from 6:30-9:30 p.m. She said questions can be submitted in advance to <a href="mailto:publicaffairs@normanok.gov">publicaffairs@normanok.gov</a>. Questions may be submitted until 4:00 p.m. on October 18th. If the deadline is missed, the question can be asked in person at the meeting. She said the goal is to connect with seasoned professionals working in Norman while critically thinking about affordable housing challenges and how to address those challenges.

Councilmember Holman said affordable housing is becoming one of the most serious issues facing the City of Norman as well as the State of Oklahoma.

<u>Second Friday Art Walk.</u> Councilmember Grant said the Second Friday Art Walk is on Friday, October 14. She said there will be a booth where people can register to vote and a Downtown Pantry Painting Party from 6:30-7:30 p.m. on the west facing side of 222 South Porter Avenue.

<u>Downtown Bid District Item was Withdrawn</u>. Councilmember Foreman said for those who might have missed the Mayor's announcement, the Downtown Bid District Items were withdrawn from the agenda at the request of the applicant. She said this is unfortunate and is very disappointed. She hopes Mr. Brewer comes back again and the Downtowners all come together on this.

Councilmember Peacock said he is disappointed about the withdrawal of the Downtown Bid District. He said he has strong opinions about this item and if the City wants to be an attractive destination for talent, business, quality of life initiatives, these types of initiatives need approval and support. He said it is a shame and a missed opportunity. He hopes to be able to revisit this issue in the future.

<u>Community Planning and Transportation (CPT) Committee</u>. Councilmember Holman asked everyone to put the CPT meeting on October 27th at 4:00 p.m. on their calendar. He said it could also be watched on YouTube.

Norman North High School Information. Councilmember Holman said he was in the sixth grade when the announcement was made to build Norman North High School. He said there was a City Wide survey of what the school colors and mascot should be. He said Norman North High School's original name was Norman High School North and in 2000, the name was changed to Norman North High School. He noted that he had the honor of serving on City Council with former Ward 8 Councilmember Dan Quinn. He said Dan was the very first principal of Norman North.

Shop Norman. Councilmember Peacock said "Shop Norman."

#### POINT OF ORDER

Councilmember Schueler called "a Point of Order" and asked for a clarification about the consent docket not being read and quoted Section 1, Article XI, of the City Charter, which states:

"Five (5) members of the Council shall constitute a quorum, and the affirmative vote of five (5) members shall be necessary to adopt any motion, resolution or ordinance, or pass any measure. Upon every vote the ayes and nays shall be called and recorded, and every motion, resolution or ordinance shall be reduced to writing and read before the final vote is taken thereon. The Mayor shall have no power to veto any measure, and he shall have a vote on all questions. Every resolution or ordinance passed by the Council must be signed by the Mayor or by the Mayor Pro Tem, acting in that capacity, and be recorded and published before the same shall be in force, except as otherwise hereinafter provided."

She said she is worried about "Upon every vote the ayes and nays shall be called and recorded, and every motion, resolution or ordinance shall be reduced to writing and read before the final vote is taken thereon."

Ms. Beth Muckala, Assistant City Attorney, said she agreed and the legal department will look further into the language that has been read regarding exactly what that means in the context of all of it.

Councilmember Schueler asked what happens if the Council finds out that this is in violation by not reading ordinances by title specifically about zoning applications, which a first reading is required.

Ms. Muckala said she would not come to that type of conclusion, ordinances are read into the record before a final vote. She said Ordinances on Second Reading are read by title. She said staff can look at the meaning of the word "read" and the scope of this as it is intended.

Councilmember Schueler expressed concerns about not reading the items and violating our Charter.

Ms. Muckala said she would not be prepared to give an opinion that the City is in violation of any Charter provision to the extent that anything needs to be ratified.

Mr. Pyle said Councilmember Schueler would have an answer first thing Wednesday morning.

Councilmember Schueler said it is plain to her that the items need to be read into the record.

Mayor Heikkila asked how he was supposed to proceed.

Ms. Muckala said there has been no determination that there is an issue. She said the Mayor was free to read the items into the record if that is what he prefers and what Mayors have done in the past, but there is a basis for how he is presently doing the consent docket.

Mayor Heikkila said he believes the Consent Docket can just be approved by voting on the Consent Docket and moved forward.

This item is placed on the agenda so that the City Council, by unanimous consent, can designate those routine agenda items that they wish to be approved or acknowledged by one motion. #### **MISCELLANEOUS COMMENTS**

<u>Problems with Agenda</u>. Mr. Steve Ellis, Ward 4, said those who set the agenda seem to give the illusion of openness rather than the reality of openness. He said the agenda information needs to be made available to Councilmembers before the weekend. He said it should also be available to citizens as well. He said it is difficult to receive 900+ pages on Monday before the Council Meeting on Tuesday. He said this also includes reading the consent docket. He is surprise that Council is so eager to take control of comments on items. He said on the public hearing item, each person in attendance receives a copy of the agenda and attachments and is eligible to speak. He feels that requirement was not met tonight and he hopes that the grant will not have to be considered again because of that. He said if there is no supporting documentation, people become suspicious.

Ms. Cindy Rogers, Ward 4, said she spends a lot of time complaining and pushing to get more information from the City of Norman, she wishes Cleveland County would step up to the plate with agenda posting and providing information to people. She compliments the City but feels the City could do better. She said having a State of the City address that is not in a public forum is bad form and not how a City engages their citizens. She hopes that the Mayor gives a State of the City that has open access and the public is invited.

<u>Turnpike</u>. Ms. Darla LeBlanc, Ward 5, said her roots in this town are very deep. She said a state entity is trying to sever those roots; the southeast extension turnpike is going straight through her living room. She said she had not gotten a good night sleep since she found out but after attending the Town Hall Meeting at CrossPointe Church where thousands of people were in attendance, she learned she was not alone. She said she has been to several City meetings and it gives her peace to know that her City stands behind her and fighting for her family. She thanked the Mayor for signing the "No More Turnpikes Pledge"; however, since then she has mixed signals about where he stands.

Miscellaneous Comments, continued:

<u>Turnpike</u>, <u>continued</u>. Ms. Linda Evans, Ward 4, said the Oklahoma Turnpike Authority (OTA) is trying to build turnpikes that will go through all of her and her neighbors' homes and all of the places of nature and peace. She said they are threatening our water supply from the aquifer and Lake Thunderbird. She said the turnpike threatens the flood plain in the 10 Mile Flat area with additional flooding. She said the people fighting this; "Pike Off OTA" is a wonderful group to be a part of as well as the legal group who have made some great progress. She said the group has been assured that City Council will fight with them. She said she hopes it is not true that some of Council has changed their minds. She said this turnpike will completely change the character of the bucolic rural area, access to the lake, and the character of Norman.

Ms. Cindy Rogers, Ward 4, said the turnpike will change Norman forever and there will be no going back. She said Ruby Grant Park also is close to the Interstate 35 and it is hard to enjoy the park because of the noise pollution.

Mr. Mark Wagner, Ward 5, said the OTA will take a lot of acreage, which will not be usable for housing, and 441 more families will be displaced. He encouraged everyone to stand together to do whatever they can to avert the turnpike.

Ms. Mary Francis, Ward 7, said sometimes change is good, but it will not be changing for the better if the turnpike is approved. She said she hopes City Council will get together a proposal and are more involved.

Ms. Debbie Saltzman, Ward 5, said the City's website says, "Building an Inclusive Community." She said calling out councilmembers during a State of the City announcement is not the path to building an inclusive community. She said a large part of Norman is not conservative and it is quite likely that Councilmember that are not conservative are representing their wards, as is their task. She asked that Council represent all of Norman. She said the largest ward in Norman is Ward 5 and Ward 5 is under attack by the OTA and in favor of development.

\*

Land Application of Bio-Solids. Ms. Sonia Potts, Ward 3, read an email dated April 26, 2022, which was sent to four members of the City of Norman/Norman Utilities Authority (CON/NUA) Leadership Team from her husband, Kevin Potts. She said packets were given to the Deputy City Clerk to provide to City Councilmembers. She said the Potts' property, which is close to the Water Reclamation Facility has previously had a contract with the CON/NUA for application of biosolids and the contract has not been renewed since 2018. The lease is with Andrew Potts. She said attached to the email is an interoffice memorandum dated June 6, 2018, from the City Attorney's Office that concluded that since Kevin Potts, who is a City employee and not a City Councilmember or Trustee of the NUA, there is no conflict of interest. The memo stated that continuing the contract would be beneficial to NUA. She said the email says the family hired an attorney regarding the possible conflict of interest and have not heard back from the City Attorney's Office. She said she also has an email from Kevin Potts to the City Attorney's Office on August 21, 2018, concluding that this issue is not in violation of the City Charter. She said the correspondence expresses their desire to get the contract updated since John Potts died in October, 2016, and the ownership of the land has changed. The use of Potts' land for application of sewage sludge is considered a beneficial reuse of wastewater and it is the most cost effective means to dispose of the sludge on the land.

Miscellaneous Comments, continued:

Land Application of Bio-Solids, continued: Mr. Kevin Potts, Ward 3, said the benefit for their family is that the bio-solids are a source of fertilizer for their hayfields. He said it is not their desire to have to terminate the contract and they have tried to work with the City Attorney's office to update the contract to no avail. He said there does not appear to be a conflict because he is a City Employee. He said this contract has been in effect for decades and he brought this to City Council as the overseers of the CON/NUA to make them aware. He said the savings to the City for land application on their property, which was noted in the City Attorney's memorandum, was somewhere between \$300,000 and \$750,000 a year. He said the average savings for a five-year period is \$2,650,000.

Ms. Mary Francis, Ward 7, said back in the 1960s, which she was in college, she used to go to Potts Dairy Farm to get milk and if there was no one there to sell her milk, she took the bottle of milk and put her money in the can. She said she loves that about Norman.

\*

Air Quality During West Side Hospital Construction. Mr. Andrew Vondall, Ward 4, said Primrose of Norman is a childcare facility where his children attend and it is located next to the construction site at the Norman Regional Hospital West Side. He said there have been a number of studies about site pollution that happens, one from the Environmental Protection Agency (EPA) that was published on December 6, 2021, that outlines the air quality outside of construction sites can be worse than inside for childcare facilities and schools. He said the pollution is not monitored inside or outside. Another study done at Portland State University in December, 2020, "The Neighborhood Quality Impact for Construction Site Emissions in Portland". This study found that the most common problem was site cleanup, which is not always done correctly can go into groundwater. He said when it comes to pollutants, Safety meetings are not held as much as needed. Construction dust and pollutants are blowing right to the school location.

Ms. Tana Fitzgerald, Ward 4, asked Council to consider regulating construction sites on properties that abut day care centers or schools for the purpose of reducing or eliminating air pollutants that are a health risk to vulnerable populations. She said she presently has a child attending Primrose of Norman, which serves infants to kindergarteners and the school abuts the construction at the Norman Regional Healthplex. She said her youngest child has attended the school since March and their oldest child attended but now is in Norman Public Schools. She said they did not know about the construction when they enrolled their children but shortly after they started attending, the construction began. She said there was lots of dust dispensing into the air but once the project broke ground, then the dust reduced significantly. She recently learned these projects can still emit a lot of particular matter throughout the life of the project. She became concerned about all of the children who go outside and play on the onsite playground. She said the director brought the kids indoors after the dust was noticeable. She said she is also concerned about some of the nearby facilities such as a skilled nursing facility. She emphasizes that she is glad the Healthplex is being expanded because it is needed. She said many of the children have parents that work at the Healthplex. She asked Council to consider amending the code to require air quality monitoring of the construction sites that are within a certain range of a day care facility, to require construction companies to give notice to day care facilities when air quality might be poor. She personally thinks that the cost of the construction job should include paying for the temporary move of the children and staff at day care facilities for the duration of the project.

<u>Talk into the Microphone</u> . Ms. Mary Francis, Ward 7, said she really appreciates those people who speak up so it will be easier for some of the elderly people in the audience to hear.
