Scope of Work

- This proposal is to replace the existing Axis cameras with New Hanwha (Samsung) cameras.
- These cameras are approved by the Norman IT department for use on the Genetec VMS system.
- Your existing cameras are all (1) megapixel cameras with the exception of (3) which are 3mp cameras.
- These new cameras can be set up to (5) megapixels each which will give you extremely good resolution where ever you may need it.
- The outdoor PTZ cameras are being replaced with new multisensor cameras which will give you a 360degree view at all times around each camera, this will eliminate a PTZ not pointing at the right place should something occur.
- These new cameras are all equipped with IR illumination for night time recording, the cameras will turn to black and white when it gets really dark, but you will have very good situational awareness even at night or in the dark should the need arise, these cameras with IR option is NOT an increase in price.
- This proposal is based on re-use of your cabling, network video recorders, Genetec licenses, poe switches and ports.
- Convergent will recess the indoor cameras where possible for a clean esthetic look.
- Convergent will get sign offs on all views from Derrick Hopkins or designated other authority.
- Convergent will program the IP addresses into the cameras that would need to be provided by Judson LeRoi with programming being provided by Judson LeRoi.
- Convergent can program these cameras for the City at an additional cost if needed.
