Your agency has been selected to receive \$48,537.70, (the Proposed Award), pursuant to the Oklahoma Office of Homeland Security (OKOHS) fiscal year 2021 Homeland Security Grant Program (the 2021 Program). Among other initiatives, the 2021 Program provides this funding for the purchase of physical security enhancements.

The 2021 Program is a federally funded grant using money provided to the State of Oklahoma as a part of the FY 2021 (FEMA/DHS) Homeland Security Grant Program. Like previous FEMA/OKOHS/ODEMHS grant programs, the 2021 Program is a reimbursement grant. The process requires the following actions:

- (1) Acceptance of the terms and conditions of the 2021 Program including but not limited to those noted on the attached *Schedule "1"*.
- (2) Submission of a Budget Detail Worksheet (BDW) to OKOHS with a list of estimated costs of specific allowable items.
- (3) Receipt of an approval letter from OKOHS with a schedule of approved items. You must have this **OKOHS APPROVAL LETTER IN HAND PRIOR TO EXPENDING FUNDS**.
- (4) After your receipt of the OKOHS Approval Letter, you may purchase approved items in an amount not to exceed the amount of the Proposed Award; and
- (5) Upon receipt of the purchased items, you will need to submit a Reimbursement Request Form, copies of the associated invoices and purchase orders to OKOHS. (Copies of the Reimbursement Request Form and the BDW are available on the OKOHS website at <a href="https://www.homelandsecurity.ok.gov">www.homelandsecurity.ok.gov</a>).
- (6) After your payment to the vendor has been processed, you will need to submit a copy of the cancelled check and an inventory form to OKOHS.

Reimbursement checks are generally mailed to sub grantees by OKOHS within 30 days of receipt of the signed Reimbursement Request Form and associated invoices. If this process will cause a significant hardship, please contact OKOHS for further guidance.

If your organization is willing to accept the Proposed Award subject to all the terms and conditions of the 2021 Program, please so indicate by: (1) affixing the signature of the
