LEGAL DESCRIPTION

Alley #2

COMMENCING at the Northeast corner of Lot 5A of said Block 1;

THENCE North 89°28'35" West, along the North line of said Lot 5A, a distance of 44.89 feet to the **POINT OF BEGINNING**;

THENCE South 00°31'25" West, a distance of 15.00 feet;

THENCE North 89°28'35" West, a distance of 17.94 feet;

THENCE South 00°31'25" West, a distance of 185.00 feet to the South line of said Lot 5A;

THENCE North 89°28'35" West, along said South line, a distance of 24.00 feet;

THENCE North 00°31'25" East, a distance of 200.00 feet to the North line of said Lot 5A;

THENCE South 89°28'35" East, along said North line, a distance of 41.94 feet to the **POINT OF BEGINNING**.

Said tract of land containing 5,069 square feet or 0.1164 acres, more or less.

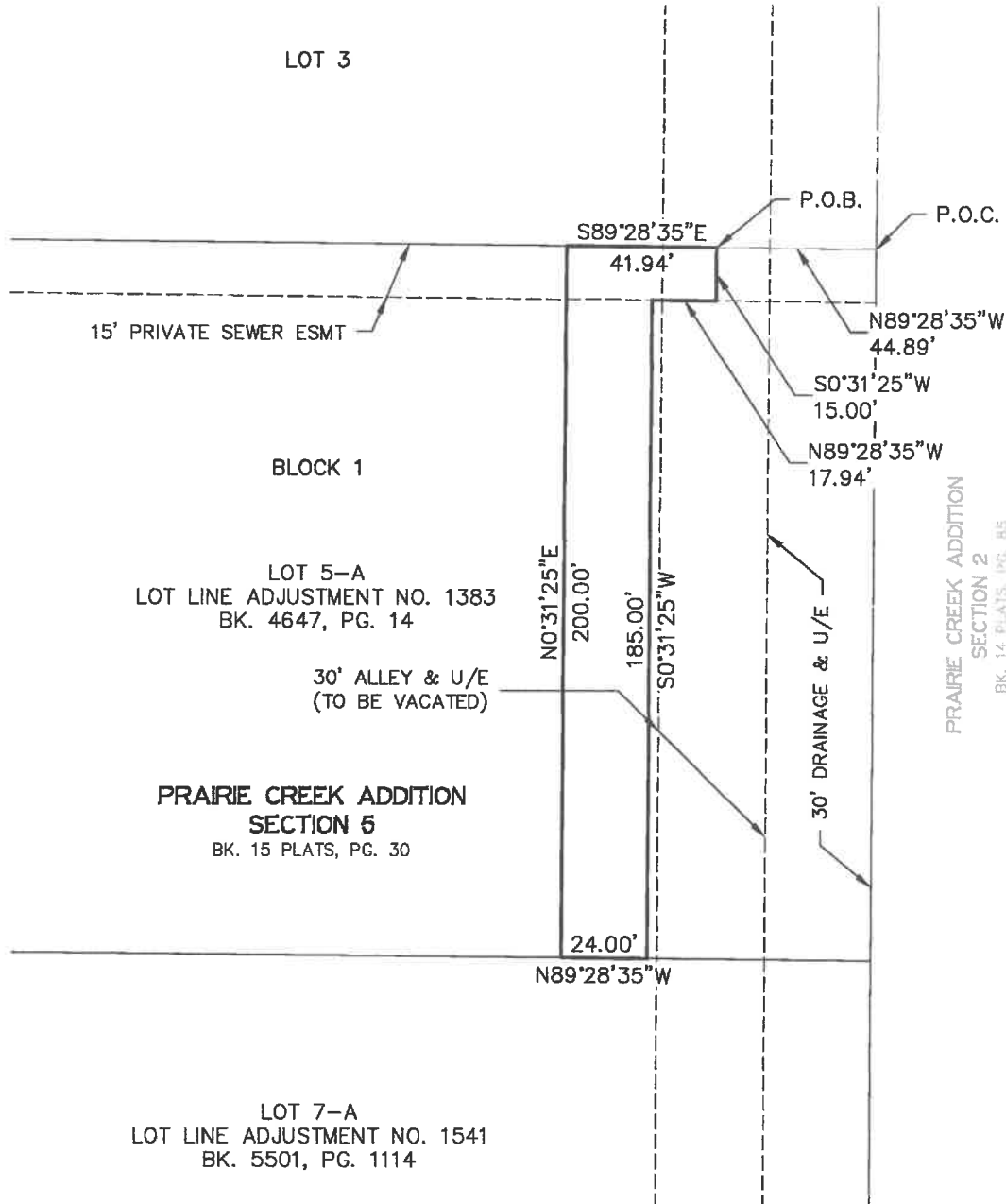

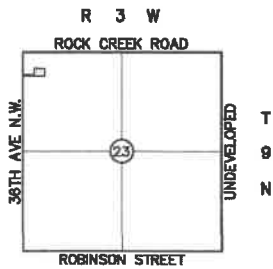

CITY OF NORMAN, CLEVELAND CO., OKLAHOMA



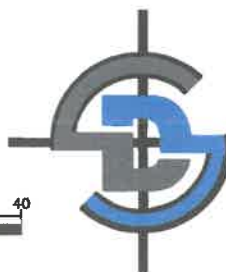
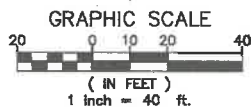
PRAIRIE CREEK ADDITION
