Contract No. K-2223-114: By and between the City of Norman and Rudy Construction Company Increasing the Contract Amount by \$650 for a Special Sign for Temporary Traffic

Control

BACKGROUND:

On March 28, 2023, City Council approved contract K-2223-114 with Rudy Construction Company for the construction of the intersection improvements of 12th Avenue NE and High Meadows Drive. To-date, the project has reached 41% of its 180 contract calendar days.

DISCUSSION:

During initial construction, it was determined that construction would proceed more efficiently if High Meadows was completely closed to place the underground drainage structures along the east side of 12th Avenue NE and under High Meadows Drive. With this closure, which was a deviation from the design plans, the City of Norman requested that a special sign be placed at the northeast corner of Robinson Street and 12th Avenue NE informing the northbound traffic that High Meadows was closed and that vehicles should follow the established signed detour. This special sign was not included in the original plans, therefore an additional \$650 was requested from Rudy Construction Company to make this sign and display it during the High Meadows Drive closure.

ACTION ITEM:

For acceptance of Change Order No. 2 under contract K-2223-114 with Rudy Construction Company for making the special traffic control sign and having it displayed during the closure of High Meadows Drive. The change in contract amount is included in the attached Change Order form. Staff also recommends the following appropriation of funds to pay for the Change Order No. 2 to Contract K-2223-114.
