## CITY OF NORMAN ORDINANCE 0-2526-15

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NORMAN DELETING SECTIONS 24-104(E)(6), REPEALING SECTION 24-308, AND DELETING RELATED FINES SET FORTH IN APPENDIX B OF THE NORMAN CODE OF ORDINANCES ALL RELATED TO THE MUNICIPAL CRIMINAL CHARGE OF PEEPING TOM; AND PROVIDING FOR THE SEVERABILITY THEREOF.

WHEREAS, State law addresses "peeping tom" activity through a criminal statute that allows for alleged offenders to be charged with a misdemeanor or felony; and

**WHEREAS**, a municipal charge of "peeping tom" is not reported in law enforcement databases in the same way as a charge from a court of record like District Court, making it more difficult to find serial perpetrators whose behavior may escalate; and

**WHEREAS**, eliminating the municipal charge of "peeping tom" from the City's code ensures alleged offenders will be charged under State law.

**NOW THEREFORE**, be it ordained by the City Council of the City of Norman, in the State of Oklahoma, as follows:

**SECTION 1:** <u>AMENDMENT</u> "24-104 Penalties" of the City of Norman Municipal Code is hereby *amended* as follows:

#### BEFORE AMENDMENT

#### 24-104 Penalties

- (a) Persons convicted of violating the provisions of NCC 24-202 shall be punished by a fine as provided in the City penalty and fine schedule.
- (b) Persons convicted of violation of NCC 24-307 shall be punished by a fine as provided in the City penalty and fine schedule.
- (c) Persons convicted of violating NCC 24-509 shall be punished by a fine and/or imprisonment as provided in the City penalty and fine schedule.
- (d) Except as otherwise provided in this section, any person convicted of violating the provisions of any section or subsection of this chapter shall be punished by a fine as provided in the City penalty and fine schedule.
- (e) Persons convicted of violating the provisions of the following listed articles, sections or subsections of this Code shall be punished by a fine and/or imprisonment as provided in the City penalty and fine schedule.
  - (1) NCC 24-201, Age misrepresentation;
  - (2) NCC 24-205, Furnishing alcoholic beverages;
  - (3) NCC 24-304, Harmful substances being possessed, sold, distributed or

#### consumed; exceptions;

- (4) NCC 24-305, Narcotics;
- (5) NCC 24-306, Nudity, indecent exposure;
- (6) NCC 24-308, Peeping Toms;
- (7) NCC 24-312, Possession or sale of drug-related paraphernalia;
- (8) NCC 24-401, Assault; battery;
- (9) NCC 24-402, Discharging firearms, exceptions;
- (10) NCC 24-403, Disturbing the peace;
- (11) NCC 24-404, Possession of certain weapons, exceptions;
- (12) NCC 24-405, Unlawful assembly;
- (13) NCC 24-406, Nuisance party;
- (14) NCC 24-407, No person shall attend or contribute to a nuisance party;
- (15) NCC 24-408, Social host; permitting or allowing gatherings where minors are consuming alcoholic beverages;
- (16) NCC 24-501, Interference with property's use;
- (17) NCC 24-502, Molesting property; exceptions;
- (18) NCC 24-503, Petit larceny;
- (19) NCC 24-504, Tampering with public utilities;
- (20) NCC 24-505, Trespass; illegal entrance; exception; and
- (21) NCC 24-VI.
- (f) Notwithstanding the above subsections, the Court may impose costs in addition to any monetary fine and/or imprisonment.

**SECTION 2:** <u>AMENDMENT</u> "24-308 Peeping Toms" of the City of Norman Municipal Code is hereby *amended* as follows:

#### BEFORE AMENDMENT

### 24-308 Peeping Toms

No person shall hide, wait or loiter about in the vicinity of any private dwelling house, apartment or any other place of residence, to watch, gaze, or look upon the occupants therein in a clandestine manner.

(a) Every person who hides, waits or otherwise loiters in the vicinity of any private dwelling house, apartment building, any other place of residence, or in the vicinity of

- any locker room, dressing room, restroom or any other place where a person has a right to a reasonable expectation of privacy, with the unlawful and willful intent to watch, gaze, or look upon any person in a clandestine manner, shall, upon conviction, be guilty of a misdemeanor.
- (b) Every person who uses photographic, electronic or video equipment in a clandestine manner for any illegal, illegitimate, prurient, lewd or lascivious purpose with the unlawful and willful intent to view, watch, gaze or look upon any person without the knowledge and consent of such person when the person viewed is in a place where there is a right to a reasonable expectation of privacy, or who publishes or distributes any image obtained from such act, shall, upon conviction, be guilty of a felony.
- (c) Every person who uses photographic, electronic or video equipment in a clandestine manner for any illegal, illegitimate, prurient, lewd or lascivious purpose with the unlawful and willful intent to view, watch, gaze or look upon any person and capture an image of a private area of a person without the knowledge and consent of such person and knowingly does so under circumstances in which a reasonable person would believe that the private area of the person would not be visible to the public, regardless of whether the person is in a public or private place shall, upon conviction, be guilty of a misdemeanor.
- (d) As used in this section, the term "private area of the person" means the naked or undergarment-clad genitals, pubic area, buttocks, or any portion of the areola of the female breast of that individual.

unlawful and willful intent to view, watch, gaze or look upon any person and capture an image of a private area of a person without the knowledge and consent of such person and knowingly does so under circumstances in which a reasonable person would believe that the private area of the person would not be visible to the public, regardless of whether the person is in a public or private place shall, upon conviction, be guilty of a misdemeanor.
