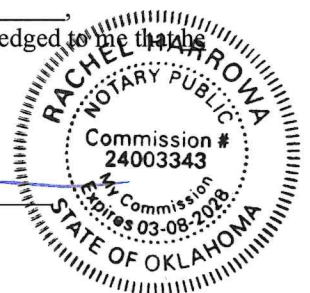

A roadway, drainage & utility easement land lying in the Northwest Quarter (NW/4) of Section Ten (10), Township Eight North (T8N), Range Two West (R2W) of the Indian Meridian (I.M.), Norman, Cleveland County, Oklahoma being more particularly described as follows:

COMMENCING at the Southeast corner of said NW/4;

THENCE North 00°23'21" East, along the east line of said NW/4, a distance of 599.86 feet to the **POINT OF BEGINNING**;

THENCE South 89°48'49" West a distance of 656.84 feet to a point on the Easterly right-of-way of Technology Place, as shown on the filed final plat of NORMAN BUSINESS PARK (as filed in Book 18 of Plats, Page 101);

THENCE North 00°23'14" East along said Easterly right-of-way a distance of 18.00 feet;

THENCE North 89°48'49" East a distance of 573.24 feet;

THENCE North 00°23'21" East a distance of 15.00 feet;

THENCE North 89°48'49" East a distance of 83.60 feet to a point on said east line of said NW/4;

THENCE South 00°23'21" West along said east line a distance of 33.00 feet;
to the **POINT OF BEGINNING**.

Said roadway, drainage & utility easement contains 0.300 acres, more or less.

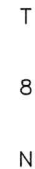
