MISCELLANEOUS COMMENTS

Public Transit

Mayumi Windler, Ward 2, expressed frustration with the public transportation schedule, noting that no bus service is available on Sundays or holidays. Over Labor Day weekend, she had to walk to Walmart due to her car being in the shop, which was an all-day event due to the heat. She advocated for Sunday bus service similar to Oklahoma City. She also criticized the Embark app as being ineffective compared to pre-pandemic times. Regarding the proposed TIF, she expressed skepticism about the benefit of outside support and shared her personal boycott of certain retailers due to past grievances.

MISCELLANEOUS COMMENTS, continued

Rock Creek Entertainment District Tax Increment Finance (TIF) Proposal

Mayumi Windler, Ward 2, expressed skepticism about the proposed TIF and the benefit of outside support and shared her personal boycott of certain retailers due to past grievances.

Dan Munson, Ward 6, voiced concerns regarding the TIF's impact on public safety. He noted that no new fire stations have been funded or evaluated for the growing area south of Highway 9. He highlighted budget reductions in the Public Safety Sales Tax (PSST) and lack of funding for capital projects in the Fire Department. He emphasized that General Fund money should not be diverted before critical public safety needs are met. He questioned the claim of 5,000 jobs being created, citing more conservative job estimates from similar projects in Oklahoma City and elsewhere.

Cynthia Rogers, Ward 4, commended the Moore Farms North Development for supporting housing and connecting to struggling commercial areas. She contrasted this with the proposed arena TIF, which she argued does not address pressing City problems like housing or income inequality. She questioned the rationale for investing \$600 million in an arena that will not significantly solve existing issues. She also highlighted that the University of Oklahoma Foundation owns the proposed land and should not need City assistance to develop it.

City Council Elections

Paul Wilson, Ward 1, humorously withdrew his intent to run for City Council. He recounted a conversation with a City employee who claimed to have previously had property stolen by Code Enforcement. Mr. Wilson criticized the perceived unfairness in how some residents are treated by City Code Enforcement. He ended by expressing his intent to vote for the mayor again.

Sustainability

Evan Dunn, Ward 7, announced upcoming breathwork classes he is teaching at The Well and next Tuesday at noon. He discussed his personal philosophy around accountability, resource conservation, and sustainability. Mr. Dunn emphasized efficient use of resources to preserve the future for upcoming generations and argued that all decisions should reflect this ethic.

Oklahoma Turnpike Authority (OTA)

Jeanette Coker, Ward 4, referenced the previous council discussion on OTA and expressed concern about the relationship between Council, constituents, and Staff. She used a metaphor to explain her perspective, likening the Council to the "head," constituents to the "neck," and Staff to a "decorator" hired to implement shared decisions. She emphasized Councilmembers must represent and prioritize the interests of their constituents over professional Staff opinions.
