MISCELLANEOUS COMMENTS

Oklahoma Turnpike Authority (OTA)

Kelly Wilson, Ward 6, thanked the Council for opposing the turnpike. Shared a personal story about the potential impact on her family's land and emphasized the importance of transparent answers from staff.

Rob Norman, Ward 3, described the meeting as a watershed moment. Urged discernment in city planning and decision-making. Advocated for rights-based democracy.

Miscellaneous Comments, continued

Oklahoma Turnpike Authority (OTA), continued

Marguerite Larson, Ward 6, encouraged the Council to protect green space, address climate issues, and hold developers accountable.

Amy Cerato, Ward 5, invited the Council to meet and discuss community-driven research and emphasized the need for inclusion over lobbying influence.

Tiffany Stevens, Ward 5, praised Oklahoma for Responsible Transportation and encouraged reliance on the group's knowledge.

Pamela Post, Ward 5, thanked the Council on behalf of Oklahoma for Responsible Transportation and supported development of new ordinances.

Tassie Hirschfeld, Ward 5, criticized the Turnpike Authority's lack of public engagement. Commended the Council's support of democratic processes.

Floyd Carroll, Ward 4, shared personal political endorsements and criticized past Council engagement. He suggested the turnpike has been planned since 2010.

Rock Creek Entertainment District Tax Increment Finance (TIF) District

Ms. Cynthia Roger, Ward 4, called for a full economic impact study for the arena TIF and highlighted the need for expert analysis and transparency.

*

Public Transit

James Livingston, Ward 2, advocated for improved public transit based on other cities' models and shared local tree-related anecdotes.

*

Highway 9

Paul Wilson, Ward 1, expressed concern over Highway 9 construction timing and safety. He suggested phased construction and added safety features.

*

Development Projects

Stephen Ellis, Ward 4, encouraged deeper policy examination and critique of special interests. Offered to engage in a dialogue with the Council on development topics.

*

MISCELLANEOUS COMMENTS, continued

House Rules/Code of Conduct

Mark Campbell, Ward 4, urged adherence to Council's code of conduct, e.g., verify information, treat people with respect, and avoid stereotypes. He criticized doxing and dehumanization of unhoused individuals and emphasized the code of conduct applies to all, including elected officials. He called for enforcement of respectful language and terminology and suggested using "Point of Order" to maintain decorum during meetings.

*

Homelessness Documentation and Community Awareness

Chelsea Gravel, Ward 4, said she represented "Norman Neighbors," a group documenting homelessness via public photography. She defended the group's practices as public journalism, not harassment, and shared that documentation has reconnected with families and informed the community. She clarified the group does not follow, incite, or threaten anyone and holds local leaders accountable through investigative journalism.

Karlinda Gravel, Ward 4, reported a direct threat from a homeless individual near her home and accused local officials and social media groups of inciting violence. She read from online posts containing threats and defamatory remarks and claimed there is a coordinated effort to label her and Chelsea Gravel as mentally ill. She called for accountability over harmful online discourse.

Sherylann Densow, Wards 4 and 6, praised public intelligence and civic involvement. She warned that Metadata can expose anonymous online users and suggested digital anonymity is not a shield from accountability.

*

Civil Rights Concerns and Police Misconduct Allegations

John Willard, Ward 1, expressed frustration with lack of response from City officials and praised the Councilmember for listening to him. He recounted alleged abuse by police and warned of legal action and requested a no-contact order against the Norman Police Department. He spoke of trauma experienced and religious motivations behind his advocacy.

*

Unity, Environment, and Health

Evan Dunn, Ward 7, reflected on universal elements in science and philosophy as symbols of unity. He supported sustainability efforts (e.g., electric vehicle chargers, solar panels) and urged investment in grassroots solutions like urban agriculture. He criticized misplaced priorities in development and promoted public health practices like fasting for metabolic benefits.
