

The posts are 9 feet in height. The lowest individual light is 8 feet 3 inches off the ground. These lights are strung using 3/32 inch cable with double cable locks, s-hooks and turnbuckles for tension. The cables are mounted to the facing of the building using 3in eye bolts screwed in at a 45 degree angle. All this will minimize sagging and allow for weather resistance. The highest point of the install is 11 feet at the building face.

This is an official request for the written permission for the continued placement of 3 manufactured steel post on the property listed above for the purpose of Place Making and safety in Downtown Norman. These posts are used to add patio lights to the address listed above. These post are manufactured and installed by Weibee Steel Company, Inc. (Attachment A). These exact posts have been used for other patio projects within the City of Norman. The commercial patio lights are purchased by JASCO (Attachment B).

The posts are 9 feet in height. The lowest individual light is 8 feet 3 inches off the ground. These lights are strung using 3/32 inch cable with s-hooks and turnbuckles to minimize sagging and allow for weather resistance. The highest point of the install is 11 feet at the building face.

<u>ALL</u> three posts are placed within the current patio dining permitted area held by Rusty's Custard Factory and approved by the City of Norman. <u>NONE</u> of the three posts are placed in the public right-of-way. These posts have been in place for the Norman Music Fest, Norman Pride Weekend and Norman Second Friday Art Walk. They are not an obstruction or impediment to the flow of traffic, which would constitute a public nuisance. Because these posts are not a structure, obstruction or impediment, I do not believe it is possible they could be a public nuisance. Rather, I suspect most people would say the additional lighting is a positive, attractive feature.

I request a temporary relief of the 10 day demand letter while a formal request is processed by the City of Norman Public Works Department. Thank you for supporting the continued growth of Norman's local small businesses and the Downtown Business District.
