

SUPPLEMENTAL EASEMENT AND RIGHT-OF-WAY

The City of Norman, 201 W. Gray Street, Norman, OK 73069, ("Grantor") owns an interest in a tract of real property that is situated within the NW/4 of Section 11, Township 9 N, Range 3 W of the Indian Meridian, Cleveland County, OK. Such tract is subject to easement(s) and right(s)-of-way in favor of WESTERN FARMERS ELECTRIC COOPERATIVE, a cooperative corporation organized under the laws of the State of Oklahoma (hereinafter called the "Cooperative"), including but not limited to the following:

Easement dated September 1, 1970 and recorded in Book 512, Page 338, of the real property records of Cleveland County, Oklahoma (the "Easement").

Cooperative is the current owner and holder of the rights, title and interest, or a portion thereof, granted in or arising under the Easement. The parties hereto desire to amend the description of the property being burdened thereby.

THEREFORE in consideration of the Cooperative relocating structures at the request of Grantor, The City of Norman, said relocation construing good and valuable consideration paid to Grantor, the receipt and sufficiency of which are hereby acknowledged, Grantor and Cooperative do hereby ratify, adopt and confirm the above-referenced easement, as modified herein as follows:.

1. Description of the property burdened by the Easement:

A strip of land with a variable width easement in the NW/4 of Section 11, Township 9 North, Range 3 West, Cleveland County, Oklahoma, and more particularly described on attached survey plat

2. All other terms of original grant from above referenced easement shall remain in force and govern.
