**OVERVIEW**

Oklahoma Department of Emergency Management and Homeland Security is anticipating awarding up to \$50,000 which will be distributed through a competitive funding opportunity for Community Emergency Response Teams (CERT) for disaster preparedness, training and education needs of Oklahomans. Funding amounts are awarded by ODEMHS. **The maximum amount per award will be \$10,000** for planning, organization, equipment, training, exercise. Interested parties may apply for funding for a CERT Program.

The Community Emergency Response Team (CERT) Program is a training program that prepares citizens to help themselves, their families, and their neighbors in the event of a disaster in their community. Through CERT, citizens can learn about disaster preparedness and receive training in basic

disaster response skills such as fire safety, light search and rescue, and medical operations. With this training, volunteers can provide critical support by giving immediate assistance to victims before emergency first responders arrive on scene.

1. Priority will be given to applicants who:
  - a. Demonstrate high- cost efficiency.
  - b. Show a high level of partnership activities.
  - c. Demonstrate significant involvement in all-hazard emergency community preparedness.
  - d. Demonstrate strong sustainability plans to sustain the program.

### **APPLICATION REQUIREMENTS**

1. Only applications that include the following completed items will be evaluated:
  - a. Completed application
  - b. Must have an “established CERT team” and/or proof (documentation) to startup of CERT team.
  - c. Letter of Support or acknowledgment from the corresponding County Emergency Management Office (except in the case where the applicant is the County Emergency Management Office)
  - d. Team biography and when it was established, or priorities for team startup.
  - e. Affiliation (whether through school/church/city/county who deploys team)
  - f. Proposed budget worksheet.
  - g. Applicant must be able to complete the project by May 31, 2024

### **APPLICATION SCORING MATRIX**

The maximum number of points that can be awarded is 100 and only applicants receiving a minimum score of 60 points will be considered for funding.

The following are the application categories:

- a. General- 5 points
- b. Program Narrative-30 points
- c. Cost Effectiveness- 10 points
- d. Proposed Budget-25 points
- e. Community Integration/Goals-25 points
- f. Jurisdiction -5 points

Applications will be reviewed through an internal and competitive review process where applicants will be scored against the above criteria and ranked. Successful applicants will be notified in writing of the intent by ODEMHS to issue the grant award. After the notice of award, ODEMHS will review the proposed budget provided with the application and provide feedback upon availability of funding. The amount funded may be less than what was requested.

**The deadline for completion is May 31, 2024. If you cannot complete by this date, you will be eliminated from consideration.**

**PROJECT TITLE/SUMMARY: CITY OF NORMAN CERT SUSTAINMENT PROJECT**

This project will provide for enhancements to the City of Norman Volunteer Response Trailer. The trailer, previously provided by an OKOHS Citizens CORPS grant supports disaster and non-disaster activities. This will provide for a shade awning for the trailer and various ancillary items of equipment to enhance operational support. This project will provide for internal team communications by purchasing handheld radios. This project will provide for a whisper quiet generator to support operations when the ambient noise of a regular generator is too loud for operations. This project will provide PPE with appropriate identifying logo for team members.

**BUDGET: \$9988.27**

### **PROJECT # 1:**

This portion of the project will allow for enhancements to the response trailer supporting the volunteer program. An external awning will be added. A smart television, with protection plan, will be added to enhance the unmanned aerial vehicle capability of the team. Additional tracks to secure equipment will be installed at lower level for safer cargo security. A rear refrigerated curtain door will be installed to maintain the A/C environment in the trailer. Additional Milwaukee pack out cabinets will be installed. Protective Counter overlay will be added to the counters. The roof will be repaired on the passenger side corner to stop leaking.

## **General:**

This application is for the CERT (Community Emergency Response Team) Program FY2022 Homeland Security Grant Program Grant Funding Opportunity. The City of Norman Emergency Management Division submits herein the application for the Norman CERT program.

## **Program Narrative:**

In 2003, The City of Norman created a new position of Emergency Management Coordinator under the Norman Fire Department. The Emergency Management Director was the Fire Chief. Concurrently the state emergency management was promoting creation of Citizens CORPS Councils. One of the first programs originated by the EM Coordinator was the Norman Citizens CORPS Council.

In 2004, by identifying an already existing structure of committees and using it as the basis for the Citizen's CORPS Committee, the Norman Citizens CORPS was created and presented to Council for approval. The Council consisted of members of the local public safety committee and the Local Emergency Preparedness Committee. Norman Emergency Management administers the program. There was an initial grant to assist in establishing the program.

During the initial phase, all five of the Citizens CORPS programs (VIPS, NWA, Fire CORPS, MRC, and CERT) were registered under the City of Norman. Over the years, the MRC and the CERT program became dominant in the state. The Norman Emergency Management maintains active participation in both of these programs. The Norman CERT program, known as the Norman Emergency Response Volunteers, and the MRC program joined in a collaboration with the Health Department and currently administers the MRC program of Cleveland County (District 10).

Over the years, the CERT program has been extremely active during disaster and non-disaster events. Average annual volunteer team hours are between 1500 to 2000 hours. Numerous highlights of the program over the years have gained the program recognition from other jurisdictions and peers. At one point, the team was the highest producer of CERT classes in the region for groups and individuals. The policies manual created for the program was utilized by other departments in the City as a guide for volunteer programs. Although there were many significant events the team participated in, two were of most significance. In 2012, the City of Norman faced a wildfire that destroyed over 15 square miles, 9500 acres, over 300 homes and 1 death. The team was instrumental in logistics support and volunteer donations management. During the event, rehab teams were formed and hand delivered food and beverages to the front line of firefighters and police. They managed massive drop off donations at the Thunderbird casino and were vital in clearing the donations in order for the casino to reopen for business. Following the massive fire the team participated in the daunting task of damage assessments, documenting every item destroyed on private property. Following the wildfire in 2013, the City of Moore was once again delivered a massive blow by Mother Nature. The CERT Team was asked to manage donations involving a

105,000 sq ft warehouse. Team members responded and operated the warehouse for 16-hour days for several months, before finally closing out the space.

The team participate in numerous community outreach items throughout the year providing contact with the residents, promoting preparedness and recruiting for new membership.

The Norman program is currently one of the longest sustained active programs in the state of Oklahoma. Since the humble start in 2003 and the formal approval in 2004, the program has continued to build and collaborate with numerous preparedness partners and community organizations to build and maintain a highly trained volunteer program under CERT.

### **Cost Effectiveness:**

The focus of this grant is to sustain the success of the Norman CERT program. In 2016, the program was awarded a grant for the purchase of a response trailer. This investment by Homeland Security provided a facility for the operation of the volunteer program during disaster and non-disaster events. The initial cost of the trailer was ~\$20,000. The City of Norman has incurred all sustainment and operational cost of the trailer over the years. On average a well-maintained cargo trailer, such as the one Norman has, can last anywhere from 10 to 15 years. This trailer is entering its 8<sup>th</sup> year of service. By maintaining this trailer and enhancing capabilities to meet current needs this trailer could easily have an extended service life into the 15 to 20 year mark, making this project very cost effective.

### **Proposed Budget:**

The proposed budget is attached. Values of items are based on retail shopping searches and quotes from service providers. Depending on the process of application, acceptance by City Council and actual expenditures, it is not expected to have a material difference in prices shown. Should that occur a budget adjustment will be submitted for approval, however, the total cost will not exceed the available grant amount.

### **Community Integration/Goals:**

#### **Community Integration:**

The City of Norman Emergency Volunteer Program is fully integrated within the community at large. Formal approval of the program by the City Council was completed in 2004. The program is written into disaster plans of the City and the Health Department. The program collaborates across numerous other volunteer programs to bring a robust and extremely active volunteer force to respond and recovery from disaster events. During non-disaster events, the program participates regularly in outreach, training, exercises and community events. The program has become well known for providing basic first aid at numerous large event venues, traffic and parking control for community markets and cooling stations during the hottest part of the summer. Several items are attached as documentation of community involvement.

#### **Goals:**

Promote and strengthen the CERT volunteer program.

Provide community residents with opportunities for training including first aid and



emergency preparedness

Provide assistance during disaster and non-disaster events

Develop community resilience through preparedness

Increase capabilities through a highly trained volunteer force

**Jurisdiction:**

The City of Norman is the third largest jurisdiction in the state of Oklahoma. The Emergency Management program is under the Norman Fire Department. The Emergency Management program was created in 2003 by the development of an Emergency Management Coordinator position. Volunteers under the EM Division have participated in every major disaster affecting Norman and in some cases the surrounding counties since its inception. The team has a very experienced base of credits. From winter storms early in the decade to extreme ice storms. From flooding to severe thunderstorms. Wildfires, tornadoes and providing relief during excessive heat. Working with other organizations such as Amateur radio, Red Cross, Salvation Army, United Way, Norman CERT has been involved in numerous events. Team members have participated in CERT training, youth preparedness camps and providing training to other jurisdictions.

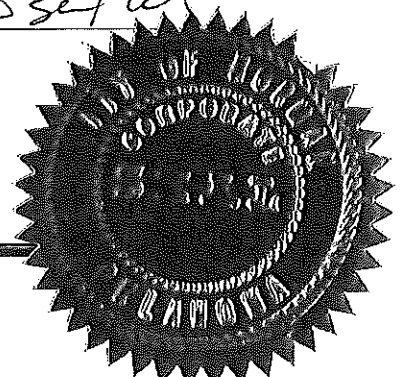
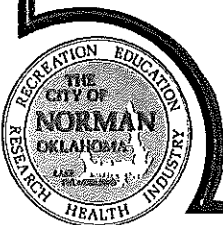

## Fire department offers safety training

In 95 percent of all emergencies, bystanders or victims are the first to provide emergency assistance or perform a rescue.

Community Emergency Response Team training can teach ordinary people to save lives or provide emergency assistance until first responders arrive.

Known as CERT, this training is free and open to the public. The three-day CERT training is taught at the Norman Fire Training Center, 2207 Goddard Avenue.

Two CERT classes have been scheduled for spring tornado season.

The next three-day class starts at 6 p.m. Thursday. The class lasts until 10 p.m., depending on class size. Friday's session also is from 6 to 10 p.m. and Saturday's runs from 8 a.m. to 5 p.m.

Participants must attend all three days to complete the

course.

A second spring class will begin on May 31 and run through June 2. Again the hours will be from 6 to 10 p.m. May 31 and June 1 and from 8 a.m. to 5 p.m. June 2, with some variation according to the size of the class.

The CERT program also teaches people about disaster preparedness for hazards that may affect this area and explains basic disaster response skills such as fire safety, light search and rescue, team organization, and disaster medical operations.

By using the training learned in the classroom and during training exercises, CERT members can assist their families and others in emergencies when professional responders are not immediately available to help.

## Grant to help disaster assistance training

NORMAN — The fire department will use a Homeland Security grant to hire a volunteer coordinator, pay for training supplies and train up to 50 people to help out in neighborhoods in times of disaster.

The city council last week approved spending \$51,500 of Homeland Security money for the project which is similar to Citizen Corps groups being organized in many cities across the state.

A part-time volunteer coordinator would get Norman's program started, Fire Chief James Fullingim said.

The city has a number of volunteer organizations already, such as Neighborhood Watch programs, Volunteers in Police Service and Citizens Emergency Response Teams. The grant money would allow for coordination of all those efforts, a uniform type of training and a more formalized program, he said.

"Five federally declared disasters in 2007 has shown the value of having (trained) volunteers," Fullingim said.

In 95 percent of all emergencies, the fire chief said, "bystanders or victims themselves are the first to provide emergency assistance or perform a rescue. Citizens that are better informed and well-trained are better prepared to take care of themselves and others during times of crisis."

Citizen Corps is "a way to harness the power of every individual through education, training and volunteer service to make communities safer, stronger and better prepared to respond to threats of terrorism, crime, public health issues and disasters of all kinds," Fullingim said.

A part-time volunteer coordinator would organize the training of 50 volunteers initially, Fullingim said.

Besides paying a coordinator, grant money would buy training kits that include fire extinguishers, radios for communication and uniforms with a body wrap design to hold equipment, the fire chief said.

The first step would be selecting the first 50 volunteers to be trained, followed by training classes.

Team building exercises and advanced training would be offered as the program progresses, Fullingim said.

"We want to train people to help others without hurting themselves. That's the basic goal," he said.

The City of Norman Citizens CORPS program is comprised of the Neighborhood Watch Program, the Volunteers in Police Service, participates in the State Medical Reserve CORPS program and has formed a core volunteer group (Norman Emergency Response Volunteers) under the CERT program. Some of the programs are more prominent than others and include other local volunteer organizations as local partners.

Although the program was established in September 2003, the City of Norman Office of Emergency Management has worked diligently for the past 5 years to resolve many internal issues of a formal program and it was not until 2007 those issues were mitigated and the program began to build. Emphasis was placed on building a solid foundation for the acceptance of volunteer programs and most of the operational activity has taken place since the middle of 2007 to current date. During 2007 the record setting federal disasters in the state have shown key City leaders the value added asset of volunteers. Currently, the Norman Citizens CORPS Council is comprised of two committees, the Local Emergency Preparedness Committee and the local Public Safety Committee. These two committees represent the local first responder community, city and county government, local business, local volunteers, the general public, private business and the University of Oklahoma. We are in the process of reestablishing the Council membership to include more local and national partner organizations.

The goal of the volunteer program is to enhance the preparedness of the city through citizen involvement and to have a value added asset the City can rely on during times of emergency.

Following a holistic approach for the programs, a policy and procedures document was created. All components of the local programs are required to adhere to this document. For the MRC, guidelines from the State Health Department were incorporated into the local guidelines and may exceed the requirements of the local Council. These guidelines address an application process, code of ethics, a background check, required, suggested and regular scheduled training. Initially training was established to support the core group on one night and the MRC on another. Due to the lack of attendance from the MRC, for calendar year 2009, training will be combined into one night and both MRC Core Curriculum and local programmed training will be used for a basis to build a training schedule. Enclosed is a draft training/events calendar.

The number of available volunteers through the various programs is fluid, but in general the CERT program has 18 core volunteers and has the local support to expand it to 50. There are several hundred CERT trained citizens identified in the Cleveland County area and outreach to locate and recruit them is ongoing. Plans are in process to hold a CERT Class in Feb 09. A local partner to the CERT program is the South Canadian Amateur Radio Society (SCARS). This HAM club has an average paid membership of 70 HAMS, which assist the city in the SKYWARN program and during other local events, both emergency and non-emergency. The OU Amateur Radio Club (OUARC) also supports the city during emergency and non-emergency events and their membership averages 12.

Norman CCORPS participates with the State controlled Medical Reserve CORPS. In an agreement with the State MRC coordinator the coordination for Cleveland County MRC local training is through the Norman CCORPS. Approximately 400 individuals are listed in the MRC database for Cleveland County.

The Norman Fire CORPS was established with a unique mission in mind. The need to care for first responders at incidents and to ensure they are mentally and emotionally able to continue their mission. This need led to recruiting the Fire Departments volunteer Chaplin to establish a Critical Incident Stress Management program. The NFC is still in the development stage, but had a verbal endorsement from the International Association of Fire Chiefs at the Citizens CORPS conference held in Jenks OK. Due to the efforts of this volunteer, internal CISM teams were formed on the Norman Fire Department and he assists on a regional and statewide basis as requested. The City Fire Marshalls Office has recently seen successes in community outreach by partnering with the CCORPS effort and has plans to build cooperation for the next year.

The Neighborhood Watch program and the Volunteers in Police Service are currently being developed with the Norman Police Department. The events of 2007 made for an excellent opportunity to pursue the development of these programs. The NWA is supervised by the Community Relations Officer of the Norman Police Department and works with over 50 listed neighborhood community associations. The VIPS program is gaining in interests and development of the Police Explorer Post and the Spouse auxiliary is currently being discussed.

I would be very willing to serve on a State Citizens CORPS Council. The previous Executive Order 1:2003-16 eff 7-25-03 (enclosed) established the States Citizens CORPS Council. However the composition of the Council did not include any Citizens CORPS Councils. It was a variety of State Agencies that produced no effort at the local level.



## **INFORMATION PAPER**

In April of 2002, President Bush called on all Americans to serve their country for the equivalent of two years or 4000 hours over the course of their lifetime. The President's initiative includes commitment to serve our neighbors and our Nation as an essential part of the American character. The President stated that we have always believed in an ethic of citizenship that includes helping those in need and promoting the common good. The Presidential solution was the Freedom Corps initiative. The Freedom Corps consists of the AmeriCorps, the Peace Corps and the Citizen Corps.

Elements of the Citizen Corps are the Neighborhood Watch programs, the Volunteers in Police Service, the Community Emergency Response Teams and the Medical Reserve Corps. The founding of a Citizen's Corp Council will enable the City of Norman to capture the spirit of service that has emerged in our community.

The Citizens Corp Council is an advisory group and does not have approval ability in regards to the volunteer programs that are in their respective jurisdictions. When forming the council it was recommended to use an existing community group such as the LEPC and adding a few additional members for the Council. It is recommended that the City local officials understand and are aware of the existence of the Citizen Corps Council.

The City of Norman has the foundation in place to form the Council from already established committees. The action of forming the Council will not adversely impact any effort already in place, rather it will bring more opportunities to participate in many different grant programs that will supplement and enhance different departmental budgets. Identifying the Local Emergency Planning Committee and the Public Safety Committee as the Citizen's Corp Council will establish a vital asset to the City of Norman.

The immediate community benefits include a greater sense of security, responsibility and personal control. The benefits for the first responders of our City include year round support through volunteer programs and creates well trained, better informed, and better prepared citizens to take care of themselves and others during times of crisis. This will allow first responders to address the most critical needs.

Everyone can do something to be safer from the dangers we all face (natural disasters, terrorism, crime, public health issues and other medical emergencies) and to help our communities be safer too. The Citizen's Corp Council will be able to take advantage of programs and organizations that provide materials and resources for public education or training. The founding of a Citizen's Corp Council will enable the City of Norman the ability to build on community strengths and develop action plans that involve the whole community.

**EXECUTIVE ORDER 2003-16**

I, Brad Henry, Governor of the State of Oklahoma, pursuant to the power vested in me by Section 2 of Article VI of the Oklahoma Constitution hereby declare the following:

1. After the tragic events that occurred on September 11, 2001, state and local government officials have increased opportunities for citizens to become an integral part of protecting the homeland and supporting the local first responders. Officials agree that the formula for ensuring a more secure and safe homeland consists of preparedness, training, and citizen involvement in supporting first responders.

2. Citizen Corps, a vital component of USA Freedom Corps, was created to help coordinate volunteer activities that will make our communities safer, stronger, and better prepared to respond to any emergency situation. It provides opportunities for people to participate in a range of measures to make their families, their homes, and their communities safer from the threats of crime, terrorism, and disasters of all kinds.

3. The mission of Citizen Corps is to harness the power of every individual through education, training, and volunteer service to make communities safer, stronger, and better prepared to respond to the threats of terrorism, crime, public health issues, and disasters of all kinds.

4. The Oklahoma Department of Civil Emergency Management will encourage and fund, as appropriate, local Citizen Corps Councils that will bring together the leadership in a community to focus on engaging citizens in homeland security measures. Citizen Corps is based on local partnerships, and the success of those partnerships dictate how effective the Citizen Corps program will be in each community. The Citizen Corps program will focus on improving partnerships within each community to demonstrate that the entire community - the private sector as well as the public sector - has a responsibility for the well-being of the community; and, also ensuring that the private sector accepts the concept that much of what happens in a community sooner or later affects their business.

5. The Oklahoma Department of Civil Emergency Management will establish and chair a State Citizen Corps Council to offer guidance and leadership to the local Citizen Corps Councils. Representatives from the following agencies will serve on the State Citizen Corps Council:

- The Oklahoma Department of Public Safety
- The Oklahoma Office of Homeland Security
- The Oklahoma Department of Military
- The Oklahoma Department of Human Services
- The Oklahoma Department of Health
- The Oklahoma Department of Agriculture, Food, and Forestry
- The Oklahoma Emergency Management Association
- The Oklahoma Community Service Commission
- Volunteer Action Centers
- Voluntary Organizations Active in Disaster

Copies of this Executive Order shall be distributed to the Director of Civil Emergency Management who shall cause the provisions of this order to be implemented by all appropriate agencies of state government.
