MINUTES

1. CONSIDERATION OF APPROVAL, REJECTION, AMENDMENT, AND/OR POSTPONEMENT OF THE MINUTES AS FOLLOWS:

AIM NORMAN COMPREHENSIVE PLAN STEERING COMMITTEE MEETING MINUTES OF JUNE 12, 2024.

Motion by Patrick Schrank to approve the AIM Norman Comprehensive Plan Steering Committee Meeting minutes of June 12, 2024; **Second** by Amanda Nairn.

This motion was approved by a vote of 12-0.

REPORTS

CO-CHAIRS REPORT.

Inger Giuffrida explained that the Co-chairs met with the OTA and confirmed that the turnpike is in the design phase.

3. SUB-COMMITTEE CHAIR REPORTS.

A. EXPANDED PRESENTATION FROM THE HOUSING SUB-COMMITTEE.

Lee Hall reported out on the Parks sub-committee. She stated that the plan is currently being drafted. Parks staff is collecting data that will be used in the plan.

Jim Adair reported out on the Transportation sub-committee. He stated in their last meeting they had open discussion on medium and long-term projects.

Amanda Nairn reported out on the Stormwater sub-committee. She stated they discussed the Water Quality Protection Zone (WQPZ) its relation to future ordinance work.

Dan Bergey reported out on the Water/Wastewater sub-committee. He explained that at the next meeting the micro-committees will transition to new topics.

Charlie Powell, RDG, and Richard McKown reported out on the Housing sub-committee. The sub-committees role was described – focus on policies and strategies on achieving the housing and price point needs.

Committee members had follow up questions regarding enforcement feasibility on the proposed recommendations. Staff followed stating that ordinances are how we are able to regulate enforcement.

Item #6: Review future land use plan was moved up on the agenda.

Amy Haase, RDG, presented the proposed land use area goals and policies, while Commissioners reviewed draft future land use maps.

Commissioners expressed concerns about the possibility of commercial development in residential areas. Staff clarified that within the land use map there are descriptors for each that explain in detail where exactly commercial is allowed. They also explained that an updated zoning ordinance would help better regulate abutting uses.
