Mr. Ellis raised concerns about inconsistent public comment practices, perceived pro-development bias, and the use of executive sessions, and cautioned that street maintenance bonds may still affect tax rates.

Ms. Hirschfeld appreciated Council's opposition to the turnpike projects but urged stronger language in official documents to reflect that stance and rebuild trust.

*

Marguerite Larson – Ward 6

Ms. Larson expressed concern about the potential impact of Council's actions on the shelter vote.

Mayumi Windler – Ward 2

Ms. Windler Expressed disappointment with recent decisions, raised concerns about transparency and governance, and noted potential impacts on upcoming elections.

Mr. Plummer opposed unconditional tax abatements for Sooner Mall and recommended tying incentives to development milestones and adding housing or a hotel to increase activity.
