Background: Two Funding Buckets

Opioid Settlement Funds

Formula-Allocated

Anticipate Receiving ~\$248,700/Year

Funding through 2038

\$830,000 Currently Unallocated

Opioid Abatement Grants

Competitive Grant Opportunities

Several Rounds Opened to Date: Additional Rounds Anticipated

Norman Received Two Grants:

- 1) 2024: \$190,000 for Virtue Center
- 2) 2025: \$498,000 for Virtue Center for 3 years



Proposed Projects for Settlement Funds

Project	Estimated One-Time or Annual Cost	Comments
Currently Funded		
A Better Way: Opportunity Knocks	\$334,000	Currently underway; total \$384,000; Sanitation covering \$50,000; expires April 2026; suggest moving project to opioid grant funding
Proposed Projects		
Additional NARCAN	\$20,000	Increase accessibility; one-time expense
Drug Treatment for City Prisoners at Cleveland County Detention Center	\$50,000	Limit to Norman residents; one-time expense
Municipal Court's Community Court	\$10,000	Mostly overtime for officers
Additional Pro-Active Community Engagement (PACE) Activities	\$20,000	Mostly overtime for officers; focused on individuals with substance abuse and co-occurring homelessness/mental health disorders
Social Worker/Outreach Coordinator	\$90,000	Provide and coordinate wrap-around Community Court/Continuum of Care services for individuals with substance abuse and co-occurring homelessness/mental health disorders
Community Resiliency Manager	\$110,000	Manage resources, coordination of services, unsheltered incident command, coordinate departmental response, permanent supportive housing, grant management, oversee Circle of Care coordination
Social Work Intern	\$7,500	Coordinate with OU School of Social Work; NPD have positive history with Social Work interns; \$2,500 stipend/semester

TOTAL Proposed One-Time Expenses: \$70,000 | TOTAL Proposed Annual Expenses: \$237,500
