RECITATIONS:

WHEREAS, the City of Novi is permitted by state statute, including the City and Village Zoning Enabling Act, MCL 125.3101 et seq, as amended by 2006 PA 110, Section 124.3406 to provide for fees and charges for acts and services performed by the City in the enforcement of its ordinances relating to the improvement of property, the construction of buildings, and the submission of planning and zoning approval requests; and

WHEREAS, the City by charter and ordinance has authorized the adoption of a fee schedule for such acts and services by resolution of the City Council, and

WHEREAS, the City Council has determined that the fees and charges set for in the 2026 *Proposed Fee Additions and Addendum to the 2024 Environmental Consultant Contract*, as extended attached hereto and incorporated herein, are necessary to

defray the costs of the environmental consultant providing required services for the administration of the City of Novi Zoning Ordinance, the Woodlands Protection and the Wetlands and Watercourse Protection ordinances.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Novi, shall, and hereby does, adopt the fee schedule attached hereto effective as of June 30, 2026.

2026 Proposed Fee Additions and Addendum to the
2024 Environmental Consultant Contract, as extended

Pre-Construction Meeting Fee

Clarification of the \$600 fee for environmental consultant to attend Pre-Construction meeting when Woodland and/or Wetland inspections are needed: one \$600 fee will be collected for the consultant's attendance at the Pre-Con meeting.

- Woodland and/or wetland pre-construction meeting fee \$600.
- If site contains both wetlands and woodlands total meeting fee will be \$600.

Single Family Residential Home Permits

- Establish a fee of \$250 for properties that require a Wetland Setback Delineation Letter (no permit)
- Establish a fee of \$500 for Woodland Staking Inspection (includes one revision)
- Establish construction observation fee of \$200 (if needed) for either woodland or wetland

The City shall collect a non-refundable administrative fee for the collection, coordination and distribution of plans and documents in the amount of 15% of the total fees as may be required in accordance with the above fee schedule.
