RESOLUTION REGARDING GARBAGE AND REFUSE RATES

Minutes of a Meeting of the City Council of the City of Novi, County of Oakland, Michigan, held in the City Hall of said City on _____, 2026, at ____ o'clock P.M. Prevailing Eastern Time.

The following preamble and Resolution were offered by Councilmember _____ and supported by Councilmember _____.

RECITALS

WHEREAS, the City adopted Ordinance No. 26-18401, amending Chapter 16, the Garbage and Refuse chapter of the City of Novi Code of Ordinances to provide, at Section 16-71, for the imposition of rates for solid waste collection, recycling, and disposal services for residential premises; and

WHEREAS, Section 16-71 states that the Council shall establish the rates by resolution from time-to-time; and

WHEREAS, the City contracts with Priority Waste to provide solid waste collection, yard waste collection, and recycling collection services for residential customers in the City, for which the City pays a contractual fee; and

WHEREAS, the City has agreed to deliver recycled materials to the facility owned by the Resource Recovery and Recycling Authority of Southwest Oakland County (RRRASOC); and

WHEREAS, the City along with other participating communities, contracts with RRRASOC to administer the recycling facility and other recycling programs in exchange for a fee paid to RRRASOC; and

WHEREAS, the City participates in the Household Hazardous Waste Collection Program administered by RRRASOC; and

WHEREAS, the City also provides certain Emergency Debris Management Services on an as needed basis; and

WHEREAS, the City has reviewed the cost of providing such services; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Novi as follows:

1. The annual user fee rate for solid waste collection, recycling, and disposal services shall be as follows effective July 1, 2026:

	SINGLE-FAMILY HOME RATE	CONDO RATE
Priority Waste Curbside Pickup (Solid Waste & Recycling for all; Yard Waste for homes only)	\$144.99	\$116.62
RRRASOC Recycling Costs (includes Member Contribution, Household Hazardous Waste, Tip Fees)	\$30.00	\$30.00
Emergency Debris Management (service provided to Single-Family Home only)	\$7.50	No yard waste collection
Total Annual Fee	\$182.49	\$146.62

2. The annual user fee rate shall be levied with the July, 2026, tax bill.

3. For curbside pickup, the single-family home rate will increase to \$148.61 on July 1, 2027, and the condominium rate will increase to \$119.53 on July 1, 2027.
