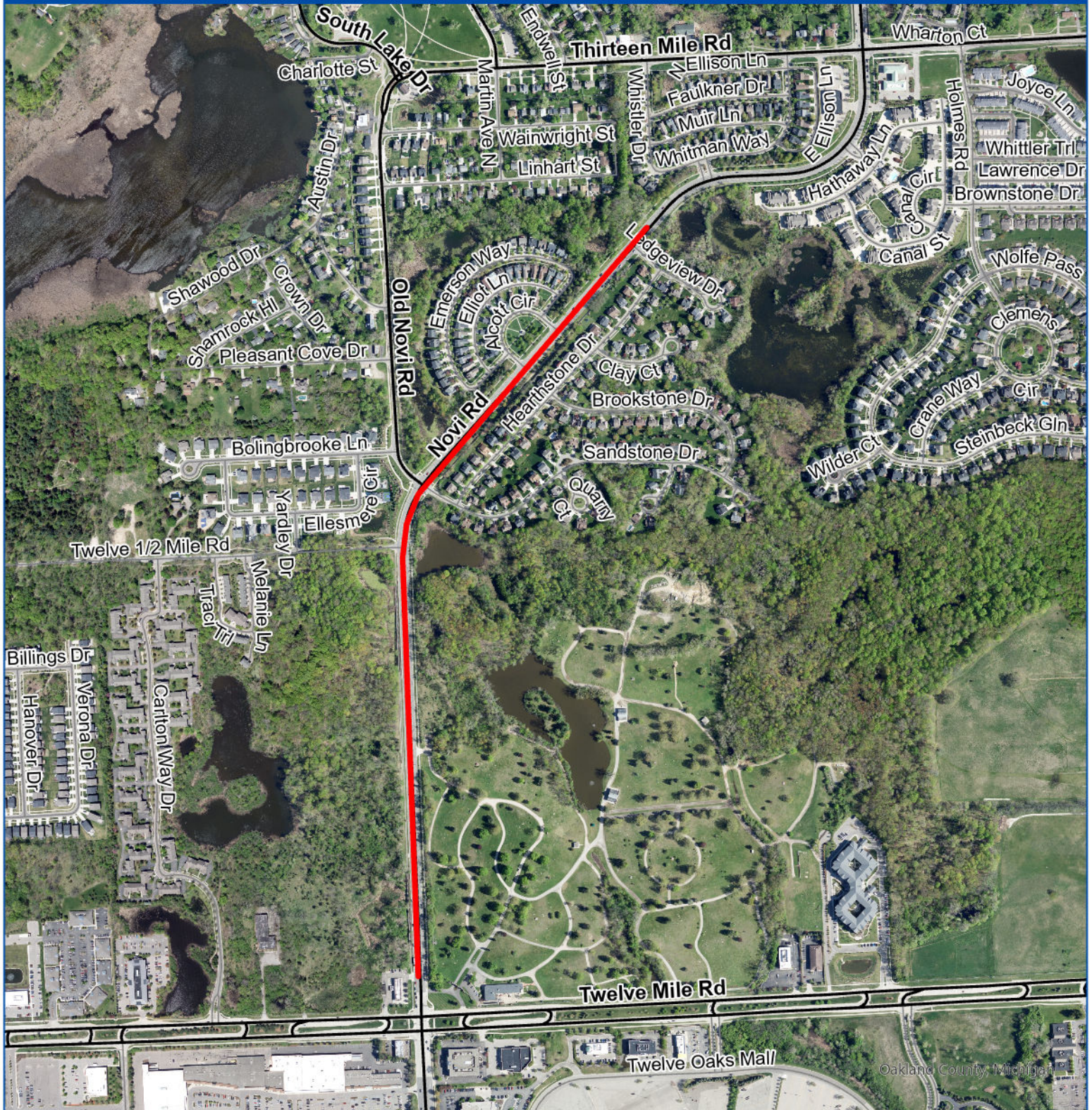
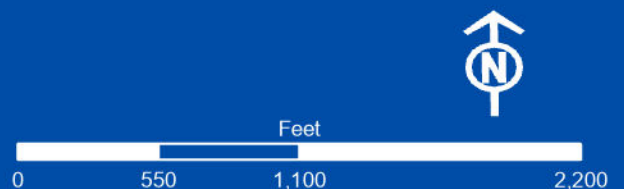


Novi Road Median Islands Drainage Improvements

Dear Mr. Croy:

On February 11, 2026 at 10:00 a.m., construction bids were opened and publicly read at the City of Novi Civic Center for the Novi Rd Medians project. The project includes storm catch basins, concrete curb, and concrete pavement construction in select existing medians along Novi Road between 12 Mile Road and 13 Mile Road.

The City Clerk's office received five (5) sealed bids for this project, with each bid considered to be responsive having submitted a bid compliant with all requirements. The apparent low bidder, Santos Cement Inc., submitted a total bid of \$596,919.25. Following the bid opening, Spalding DeDecker reviewed all of the bids received, verified the calculations, and prepared the bid tabulation for the project (attached).

Based on a review of experience and references provided, Spalding DeDecker finds that Santos Cement Inc. is qualified to perform the required construction.

It is our recommendation that the project be awarded to the lowest responsive bidder, Santos Cement Inc. in the amount of \$577,719.25 which is the total bid of \$596,919.25 minus \$19,200.00 for crew days bid.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds, and Insurance information with Santos Cement Inc.
