RESOLUTION LOCAL TRANSPORTATION REIMBURSEMENT PROGRAM

Minutes of a Meeting of the City Council of the City of Novi, County of Oakland, Michigan, held in the City Hall of said City on May 8, 2023, at 7 o'clock P.M. Prevailing Eastern Time.

The following preamble and Resolution were offered by Councilmember _____ and supported by Councilmember _____.

WHEREAS; the Oakland County Board of Commissioners has appropriated funds for the Oakland County 2023 Interim Local Transportation Reimbursement Program (the "Program") for eligible cities, villages and townships in Oakland County; and

WHEREAS; the Program seeks to assist eligible cities, villages and townships in Oakland County by providing limited reimbursement funds to maintain existing public transportation services; and

WHEREAS; the City of Novi (the "City") wishes to submit an application to the Oakland County 2023 Interim Local Transportation Reimbursement Program for a total cost not to exceed \$172,550; and

WHEREAS; the Oakland County 2023 Interim Local Transportation Reimbursement Program funds shall be used to supplement the Municipal Credits received from SMART for eligible public transportation expenses; and

WHEREAS; the Reimbursement Program requires that City certify compliance with all Program requirements.

NOW THEREFORE BE IT RESOLVED the City of Novi Council hereby approves the completion and submission of the Oakland County 2023 Interim Local Transportation Reimbursement Program application to seek funding through the Program for a total project cost not to exceed \$172,550.

BE IT FURTHER RESOLVED that the City of Novi shall supplement Program Reimbursement funds with Municipal Credits from SMART in an amount not to exceed \$172,550.

BE IT FURTHER RESOLVED if the Application is approved by Oakland County, the City's participation in the Program and the appropriation and expenditure of funds necessary or appropriate to fund its obligations under the Program as set forth in the Interlocal Agreement.

BE IT FURTHER RESOLVED that the City of Novi will comply with the Program's requirements, including submittal of semi-annual Request for Reimbursement including reports and other documentation as required by the County, as a condition to receiving reimbursement in accordance with the Program.

BE IT FURTHER RESOLVED that the City Manager or his/her designee will be authorized to sign all program-related documents on behalf of City of Novi and take any other action necessary or appropriate on the City's behalf to participate in the Program.
