MATTERS FOR COUNCIL ACTION:

- 1. Consideration of approval of a contract to CSM Mechanical, LLC., for an emergency repair of the Drakes Bay Sanitary Lift Station in the amount of \$161,967.**

The City Manager reported that last month there was an accident at a lift station on Wixom Road. These are the costs to repair that immediately. They are working with the City's insurance agent to recoup those costs. The City is fortunate that they've gotten most of a recoup of these kind of losses. They're hoping for the best but at this point they have not heard a definite, but this is how much it will cost from what their contractor has provided them.

Member Smith asked if there was something that could be done to make it safer from this type of thing. Director Jeff Herczeg responded that the lift station had bollards in place and the truck blew through them and the speed limit he thinks is 35, so this was unusual. He doesn't know if there's any more measures that they could take to protect the stations.
