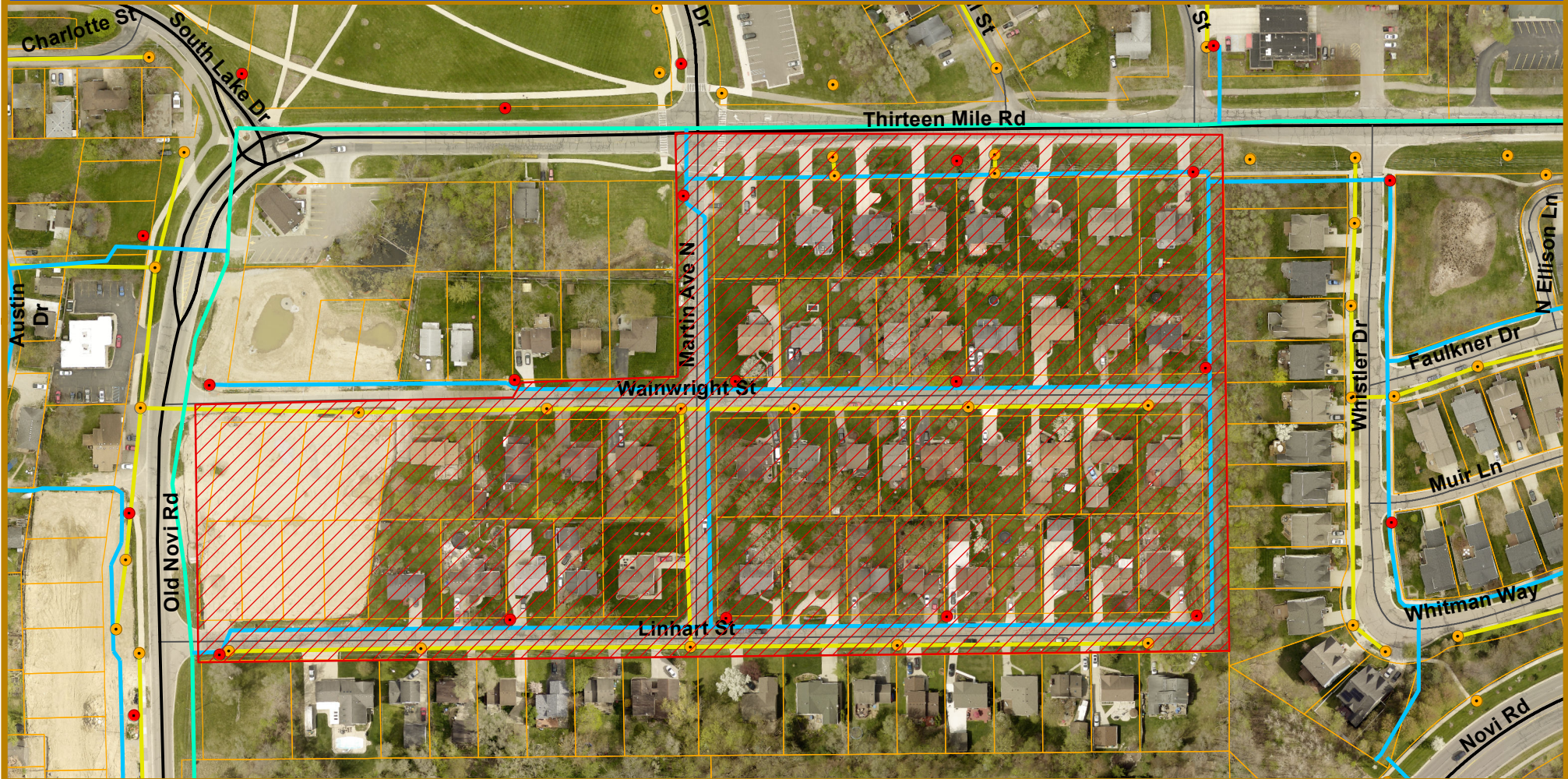


Howell's Walled Lake Subdivision Water Main Replacement, Road Improvements and Sanitary Sewer Lining

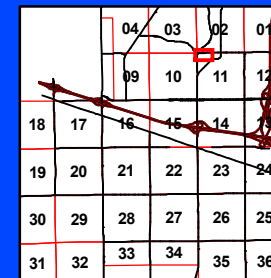
