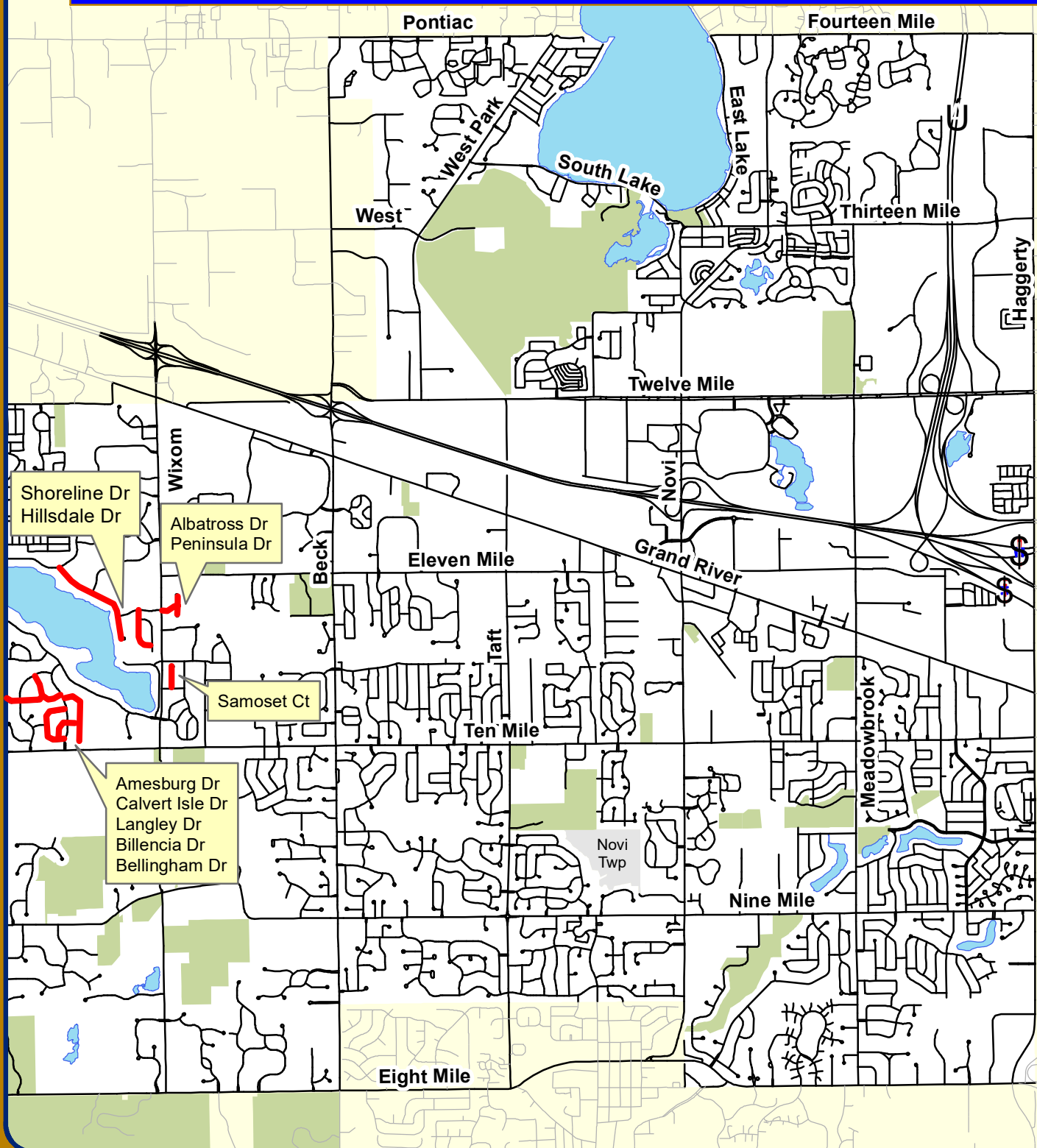

Dear Mr. Croy:

Attached is the Bid Tabulation for the above referenced project. Two bids were received and opened on July 12, 2023. Competition appears to have been good as we were only anticipating two Contractors to bid on this project. A typographical error was noted in the second highest bidders. The error did not impact the order of the bidders.

The low bid is higher than the Engineer's Estimate for the Project, but it is within the City's allotted budget for this work and bid unit prices are within an expected range given the scale of the project.

Ajax Paving Industries, Inc., the low bidder for the project, is well versed in all manner of HMA work and is a high performing Contractor. The bonding company listed in the Statement of Qualifications has an AM Best rating that exceeds the minimum requirements.

With the Fixed Price-Variable Scope nature of the project, the plan was to increase the scope of the project, if possible, given Contractor's bids. Since the total bid amount is very close to the current allotted budget set forth by the City, we do not recommend expanding the scope at this point. We recommend award of contract for the contract work to Ajax Paving Industries, Inc. for \$866,078.70. The amount bid for Inspection (Crew Days) is not included in the award amount.

The undersigned attaches hereto its Bid security, as required by the Advertisement for Bids and Instructions to Bidders. The undersigned agrees that in case it shall fail to fulfill its obligations under the foregoing Bid, and/or shall fail to furnish bonds, as specified, the OWNER may, at its option determine that the undersigned has abandoned its rights and interests in such Contract and that its Bid security accompanying its Bid; has been forfeited to the said OWNER, but otherwise the Bid security shall be returned to the undersigned upon the execution of the Contract and the acceptance of the bonds.

The undersigned also agrees that for each and every calendar day that he may be in default of any of the completion times listed above, the OWNER will suffer a damage of One Thousand Dollars (\$1,000.00) per calendar day, and said OWNER shall be compensated therefore at the rate as liquidated damages in accordance with the Agreement.
