#### I. CALL TO ORDER

Chair McCloud called the meeting to order at 6:00 p.m.

#### II. OATH OF OFFICE

Deputy Town Clerk Winzler administered the Oath of Office to Lisa Lee Kozlowski for appointment as a regular member, and Jason C. Stahr for appointment as an alternate member to the Zoning Board of Adjustment.

#### III. ADOPTION OF AGENDA

#### V. OLD BUSINESS

A. Mediation Settlement Agreement in the Case of the Town of North Topsail Beach versus Phillip H. and Kristen A. Buckley (#AA23-000003)

Town Attorney Ferguson explained the issue was set for appeal earlier in 2024, the property owner's attorney requested mediation, the mediation occurred, the terms of the mediation settlement were confidential, and there was a reduced civil penalty to be paid to the Town within thirty days of a decision by the Board of Adjustment. He explained that he understood the previous Town Attorney had attended the mediation and recommended the settlement.

Ms. Kozlowski made a motion to accept the mediation settlement agreement in the case of the Town of North Topsail Beach versus Philip H. and Kristen A. Buckley AA23-00003. Mr. Malcolm seconded the motion. The motion passed unanimously, 5-0.
