Recommendation

Staff recommends approval of the Lawful Gambling Permit for Fore Childrens Foundation and recommends requesting a waiver of the waiting period.

 LG220 Application for Exempt Permit An exempt permit may be issued to a nonprofit organization that: conducts lawful gambling on five or fewer days, and awards less than \$50,000 in prizes during a calendar year. If total raffle prize value for the calendar year will be \$1,500 or less, contact the Licensing Specialist assigned to your county by calling 651-539-1900.
