6. Consideration of a Resolution of Acceptance of Public Improvements - 20th Street Lift Station Improvements project

20th St. Lift Station improvements started in September of 2017. This project was to be completed in one weekend and completed by the fall of 2017. While 90 percent of the work was done in 2017, repeated attempts to close out the project with the contractor were unsuccessful. The city owes \$30,000 on the project to the contractor but will not pay out due to the lack of cooperation with the contractor. The city knew the contractor could be an issue, but with a bid \$86,000 under the engineer estimate and \$25,000 under the closest bid, the city did not have a good option. The City Administrator anticipates that this discussion is not over as the contractor is working with an attorney. The City Administrator recommends approving the resolution.
