The committee is excited to work with the council to bring the 2027 and 2028 IFA Convention to Oelwein and make it a great success. During tonight's work session, a few requests will be made. These items will need to be discussed now as we are in the planning stage and will dictate how we will continue. The following pages will give an overview of the previous mentioned areas.


The following requests are being made tonight.

- Use of the Veterans Park Sports Complex parking lot and concession stand. A 40 x 60ft tent will also need to be erected by the concession stand. This is for the use of registration and camper staging as well as providing a location to fill campers with onboard water.
- Closure of the Bike Trail from 10<sup>th</sup> St Se to the Sports complex. This will only need to be closed from the Friday before the event until the Monday of the event. (09-03-2027 to 09-13-2027 and 09-01-2028 to 09-11-2028). This ensures the safety and security of the event goers and the citizens of Oelwein. Further explanation is provided on a following page.
- Changing the traffic flow on 10<sup>th</sup> St Se/Old Road. From the Campground entrance to 2<sup>nd</sup> Ave Se would be ONE WAY ONLY traveling to the West. From the Campground entrance to East Line Road/Outer Rd would be 2-WAY traffic. This is needed as the point of entry to the campground is at a blind spot of the roadway and is a safety stand point. Public Safety Chief Logan was contacted and helped devise this plan. Citizens and Businesses along 10<sup>th</sup> St Se would be given permission to utilize this road still as a 2-way road to their residence/business. (This is due to the fact of them turning off before the blind spot of the roadway.)

Again, these are the only preliminary requests with other requests made as the event planning continues. Safety will always remain a top priority in planning this event.

Thanks for the time allowed to us tonight. We appreciate the chance to work with the Mayor, City Council, and Employees of the City of Oelwein.

**REGISTRATION**



Campers will enter in from the west entrance and proceed through the parking lot as shown. They will exit the east entrance when finished. The concession stand will be used as well as erecting a tent. Inside the tent will be an area multiple people can sign in or register. Also, campers can fill their on-board water tanks. This will be used from Wednesday until Saturday.

# CAMPGROUND



The Campground will be constructed on OCAD's property between Old Road and 14<sup>th</sup> Street Se. This area will be where participants will camp, attend entertainment and eat 2 catered meals. A power grid system will be designed and installed on this site. Alliant will run the power to the property line and a secondary company will be needed to install the power grid. After the 2028 convention, this will all be removed and returned to OCAD in the original condition. With the bike trail running through the middle of the property, this is why it would need closed to maintain safety and security of the event. The bike trail will have 1 designated crossing point (shown by blue box icon) to access the far west piece of property. The remaining bike trail will be closed off to keep golf carts and vehicles off. It is requested that the bike trail be closed from 10<sup>th</sup> Street to the sports complex. The entire border of the campground will be fenced off. The entrance will be staffed keeping anyone not registered for the event out. This is a security factor. The entrance is marked with a star. Committee members will also do random roaming patrols of the border to ensure compliance

## Traffic Flow



The red arrows show how campers will come from the complex. This keeps campers from utilizing 14<sup>th</sup> St Se. This avoids and disruption to East Penn's operations. The blue arrows are the requested traffic flow change for the week of convention. Signage will be requested at a later date. The blue block is the point of traffic flow change.

## CONTEST AREA



This area would be used on the Saturday of Convention for State Contest. This is a general area. Finalized plans would be presented to the council in the future. There are several contests that will be held during the day. IFA representatives will visit Oelwein a few months in advance to access the roadway conditions. By holding this event downtown, it will shut traffic down however, will be a great increase of foot traffic to the businesses and restaurants as event goers will patronize them. Also, it should be noted that in previous experience, the citizens of town will also come and spectate drawing more patrons into these businesses. It should also be noted that Non-profit groups and a few food trucks may set up near this event. This is still a work in progress however.
