ARTICLE III

RATES

SECTION 16-40. LANDFILL RATE CLASSIFICATION; CHARGES AND COUNTY RECYCLING PROGRAM FUND.

1. Landfill charges shall be assessed and collected through the City of Oelwein on an annual basis, to be paid pro rata with each customer water bill as follows:

SECTION 16-41. DELINQUENT ACCOUNTS – PENALTY.

A penalty as provided by the City's Fee Schedule shall be added to all unpaid bills after the fifteenth day of the month following the service period. In the event, the fifteenth of the month referred to here shall fall on a Saturday, Sunday or legal Holiday, no such penalty shall be applied if the bill is paid, in full, on the first business day following. (Ord. No. 938, Section 6, 05-12-1997; Ord. No. 1169, 10-22-2018.)

SECTION 16-42. DELINQUENT ACCOUNTS – COLLECTION.

Landfill and recycling charges, including penalties, if not paid as herein provided, when due, shall constitute a lien upon the premises and shall be billed and collected as provided in Section 7-47. (Ord. No. 938, Section 6, 05-12-1997.)

SECTION 16-43. CUSTOMER GUARANTEE DEPOSITS FOR LANDFILL/RECYCLING.

Deposits representing the usual cost of ninety days of landfill and recycling service shall be required of all utility and enterprise customers having no established credit record with the City or who have a prior record of failing to timely pay for such services. Customers establishing acceptable credit records with the City for three years may have their deposits returned. An occasion or reoccurrence of poor payment performance shall require a deposit to be reimposed to maintain continuation of city services. (Ord. No. 938, Section 6, 05-12-1997.)

SECTION 16-50. DEFINITIONS.
