Jean Kane, 1311 E Charles St spoke on 2 items regarding Fayette Co Outer Road project and city assessments.

- 1. Not to assess residents the full portion of the City's 45% because of the high traffic on the road.
- 2. Photos were provided showing the gravel and a mix placed on the shoulders in the city limits when city was told it would be dirt shoulders. The rock/mix excessive and caused a terrible mess in the right of way.

Council discussed not approving project completion but was confident the city would address and correct this issue. Council was concerned we may lose our bargaining power if we approve the project but the City could withhold payments to the county.

Regarding the 5-year payback for the City agreed portion of funds for county project. Joel Fantz, Fayette County Engineer, will be contacted regarding the gravel shoulder, if no cooperation, then escalated to Fayette County Supervisors
