Water

- Goal
 - \$779,500 loan for Water Infrastructure Project
 - Already awarded \$600,000 in CDBG funds
 - 1,300,000 for an additional project/projects
 - Loan payment would be used on a future potential project
 - \$100,000 annual revenue for capital improvement projects in water
 - Upcoming copper and lead regulations



Rates

- The City needs to generate \$240,000 annually to make the requested obligations
- The City should be able to pay off two loans by 2027 opening \$240,000 annually
 - 2010 SRF \$100,000
 - 2106D SRF \$80,000
- This puts Oelwein in a five-year plan
- Continuing a two percent increase is a good practice



Increase

- Five-year plan
 - 6% 2021
 - 6% 2022
 - 6% 2023
 - 2% 2024
 - 2% 2025

- Infrastructure Fee
 - \$7.00 2021
 - \$8.00 2022
 - \$8.00 2023
 - \$8.00 2024
 - \$8.00 2025



- The increase leans 70 percent toward rates and 30 toward fees
 - Rate increases effect higher users the most versus a fee increase
- Industry and higher users see a larger increase
- The City is removing the higher user categories that offered discounts
 - Only two businesses qualified for this

Wastewater/Sewer

• Goal

- \$1,000,000 Reed Bed Expansion
- \$300,000 Nutrient Reduction
- \$200,000 Clean Out Equalization Basin Replace Liner
- \$200,000 Sewer Main Replacement
- \$135,000 UV Disinfection
- Infiltration/Inflow (INI Study)
- Improvements to 4^{th} and 5^{th} NE
- \$100,000 annual revenue for capital improvement projects in sewer/wastewater
- \$70,000 in operating loss needs to be reconciled



Rates

- The City needs to generate \$320,000 to make the requested obligations
- The City should be able to pay off three loans by 2027 opening \$650,000 annually
 - 2005 SRF \$580,000
 - 2012 SRF \$50,000
 - 2017 SRF \$20,000
- Once the city enters 2027, cash can be used for projects to help reduce cost of loans



Increase

- Five-year plan
 - 6% 2021
 - 5% 2022
 - 5% 2023
 - 2% 2024
 - 2% 2025

- Infrastructure Fee
 - \$3.00 2021
 - \$4.00 2022
 - \$4.00 2023
 - \$4.00 2024
 - \$4.00 2025



- The increase leans 70 percent toward rates and 30 toward fees

- Industry and higher users see a larger increase
- The City is removing the higher user categories that offered discounts
