As an interested McLoughlin Neighbor that owns property adjacent to this building, I continue to ask the same questions and have yet to receive a clear response:

I wonder . . . if the owner is so adamant that this is just a residential building, why do they complain they can's afford to install commercial elevators? — just install residential lifts! We have asked several times to be shown the expenses for the interior elevator system that the owner claims are beyond their budget, and yet nothing is ever provided.

The owner is insistent that they need to adhere to commercial ADA requirements. If this is a residential building, why do they need to meet the "commercial" level laws? It is not necessary to create a monstrosity of a residential building for such a tiny little business. Keep the ramps and walkways looking residential.

I am supportive of assisted living centers in our community, and we have another such one on Madison street. Just because you are almost done shoving through on the work without complying with the recommendations, does not mean that the work is done. You are building this for an elderly vulnerable population that does not have a voice in the decisions you are making . . . ramps, elevators, lifts, exposed walkways.

Let's start working together to find a solution without circumventing the ADA requirements for a quick fix or creating a labyrinth of ramps when these future family members/residents deserve an interior elevator or lift to get to their homes. Let's find make sure there are safe means for escaping the building in an emergency. Let's make sure there is neighborhood-friendly parking for the workers and a private place for them to relax without creating "smoking" porches in our backyards.

Make this right. Make this part of our neighborhood that we live in. Make this safe for the residents that will live in it.
