### **Commitment to Renewables**

- Pioneer is the only utility in the region that offers a 100% renewable product
- Participation in Green100 is voluntary and affordable. Customers can select this option at any time.
- The City of Auburn opted up to Green100, lowering the amount of CO2 being released into the atmosphere by 2.1 million pounds (the equivalent to avoiding 2.4 million miles driven by the average gasoline fueled car)
- The Cities of Grass Valley and Nevada
   City opted up to Green100 in 2024


