RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE FLORIDA, APPROVING AN AGREEMENT BETWEEN "2" SBW & ASSOCIATES, INC. AND THE CITY OF PAHOKEE FOR PHASE I FOR THE REPLACEMENT & INSTALLATION OF NEW SIDEWALKS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Pahokee, Florida (the "City") issued Request for Proposals No. 2022 -01 (the "RFP") to identify a contractor to provide construction services for Phase I of the Replacement and Installation of New Sidewalks; and

WHEREAS, "2" SBW & Associates, Inc. ("Contractor") was the lowest responsible proposer to the RFP 2022-01 issued by the City and desires to contract with the City for Phase I of the Replacement and Installation of New Sidewalks; and

WHEREAS, the City and "2 SBW & Associates, Inc. mutually recognize the need for entering into the Agreement attached as Exhibit "A" hereto designating and setting forth the responsibilities of each party; and

WHEREAS, the City Commission of the City of Pahokee, Florida believes that entering into the Agreement attached as Exhibit "A" with "2" SBW & Associates, Inc. in the amount of \$104,275.18; and

WHEREAS, the City Commission of the City of Pahokee, Florida believes that entering into the Agreement attached as Exhibit "A" with "2" SBW & Associates, Inc. in the best interests of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AS IT FOLLOWS:

<u>Section 1.</u> <u>Adoption of Representations.</u> The foregoing "Whereas" clauses are hereby ratified and confirm as being true, and the same are hereby made a specific part of this resolution.

<u>Section 2.</u> <u>Authorization and Approval.</u> The City Commission of the City of Pahokee hereby authorizes and approves the Agreement between the City of Pahokee and "2" SBW & Associates, Inc. for the Phase I for the Replacement & Installation of New Sidewalks, and further authorizes the Mayor to execute the Agreement attached hereto as Exhibit "A".

<u>Section 3.</u> <u>Authorizing City Manager</u>. The City Commission of the City of Pahokee hereby authorizes the City Manager to take all necessary and expedient action to effectuate the intent of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall be effective immediately upon its passage and adoption.
