A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN CAREERSOURCE PALM BEACH COUNTY, INC. AND THE CITY OF PAHOKEE, AS SET FORTH HERETO IN EXHIBIT "A"; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Pahokee ("City") desires to enter into a Memorandum of Understanding (MOU) between CareerSource Palm Beach County, Inc. and the City of Pahokee; and

**WHEREAS**, the purpose of the MOU is to provide work experience and training opportunities for participants; and

WHEREAS, the term of the Agreement shall begin on the date last signed by both parties "shall be automatically renewed annually without action of either party, unless earlier terminated pursuant to the terms of the MOU; and

**WHEREAS**, the City Commission of the City of Pahokee deems approval of the MOU in the best interest of the City of Pahokee and its residents.

# NOW THEREFORE, BE RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> <u>Adoption of Representations.</u> The foregoing "Whereas" clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.
- <u>Section 2.</u> Approval and Authorization. The City Commission of the City of Pahokee hereby authorizes the City Manager to execute the MOU, attached hereto as Exhibit "A." The City Manager is further authorized to take all necessary and expedient actions to effectuate the intent of this Resolution.
- <u>Section 3.</u> Conflict. All resolutions in conflict herewith are hereby and expressly repealed.
- <u>Section 4.</u> <u>Effective Date</u>. This Resolution shall be effective immediately upon its passage and adoption.
