

## **RESOLUTION 2025-27**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE A STATE HIGHWAY LIGHTING, MAINTENANCE, AND COMPENSATION AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Pahokee ("City") desires to enter into a State Highway Lighting, Maintenance, and Compensation Agreement with the State of Florida Department of Transportation (FDOT) to undertake the maintenance and operation of lighting on the State Highway System within the City for Fiscal Year 2026-2027; and

**WHEREAS**, FDOT is authorized pursuant to Sections 334.044 and 335.055, Florida Statutes, to enter into this Agreement with the City; and

**WHEREAS**, FDOT has identified sites within the City where lighting and/or lighting systems, referred to as "Facilities", are located and will pay the City the sum of \$ 50,784.64 for maintenance of 146 poles; and

**WHEREAS**, it is necessary for the City Commission of the City of Pahokee to authorize the City Manager to execute the agreement so that the City may undertake the maintenance and operation of certain lighting on portions of the State Highway System within the City to include SR 15/98 (E 7th St), SR 700 (Lake Shore Dr.) SR 729 (Farmers Market Road), as more specifically described in the relevant Agreement attached hereto as Exhibit "A"; and

**WHEREAS**, the City Commission finds that it is in the best interests of the City of Pahokee to approve the State Highway Lighting, Maintenance, and Compensation Agreement with FDOT, attached hereto as Exhibit "A."

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA:**

**Section 1.** Adoption of Representations. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

**Section 2.** Authorization and Approval. The City Commission of the City of Pahokee hereby authorizes the City Manager to execute the State Highway Lighting, Maintenance,

and Compensation Agreement with the State of Florida Department of Transportation, attached as Exhibit A.

**Section 3.** Necessary Action. The City Manager is hereby authorized to take all necessary and expedient action to effectuate the intent of this Resolution.

**Section 4.** Effective Date. This Resolution shall be effective immediately upon its passage and adoption.
