

RESOLUTION 2025-40

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, APPOINTING TWO NEW MEMBERS TO THE PARKS AND RECREATION ADVISORY BOARD TO FILL TWO UNEXPIRED TERMS; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article V, Section 2-162 of the City of Pahokee's Code of Ordinances established the Parks and Recreation Advisory Board consisting of five (5) members who are citizens of the City appointed by the City Commission for a two-year term; and

WHEREAS, the Parks and Recreation Advisory Board assists in planning recreational and playground sites, activities, capital improvements, programs, and other matters as requested by the City Commission or City Manager; and

WHEREAS, the City Commission of the City of Pahokee ("City Commission") desires to fill two vacancies related to the unexpired terms of two members who have resigned. Specifically, the City Commission desires to appoint Artiona Hickman to fill the unexpired term of Tanzaneria Allen. Further, the City Commission desires to appoint Andrea Scott to fill the unexpired term of Jomaine Milton; and

WHEREAS, the City Commission finds that it is in the best interest of the City to fill two vacancies of the Parks and Recreation Advisory Board.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA:

Section 1. Adoption of Representations. The foregoing "Whereas" clauses are hereby true and correct and incorporated by reference.

Section 2. Appointment of Member. The City Commission hereby appoints the following persons to serve on the Parks and Recreation Advisory Board for the unexpired terms of their predecessors:
1) Artiona Hickman to fill the unexpired term of Tanzaneria Allen; and
2) Andrea Scott to fill the unexpired term of Jomaine Milton.

Section 3. Effective Date. This Resolution shall be effective immediately upon its passage and adoption.
