

**RESOLUTION NO. 2026-05**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AUTHORIZING AN AGREEMENT BETWEEN THE CITY OF PAHOKEE AND ANGELA REYES, LLC FOR THE PROVISION OF FINANCE SERVICES, ACCOUNTING SERVICES AND FOR ASSISTANCE WITH OIG COMPLIANCE RESPONSES, CORRECTIVE ACTION PLANS AND RELATED SERVICES IN AN AMOUNT NOT TO EXCEED \$85,000.00, IN THE CONTRACT FORM ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City desires to engage a finance professional to support certain finance and accounting services needed for the work of its Finance Department; and

**WHEREAS**, the Interim City Manager is requesting City Commission approval for a contract with Angela Reyes, LLC to assist the City of Pahokee with certain finance services, accounting services, OIG compliance responses and implementation of corrective actions required by the Palm Beach County Office of Inspector General (OIG) Audit 2025-A-0002 and the Florida Auditor General Operational Audit 2025-195, in a contract form not to exceed \$85,000 for a six month term; and

**WHEREAS**, the City Commission of the City of Pahokee deems the expenditure of these funds for services to be provided by Angela Reyes, LLC to specifically address finance and accounting support and audit findings flowing from the Palm Beach County Office of Inspector General (OIG) Audit 2025-A-0002 report, and also a Florida Auditor General Operational Audit Report 2025-195 as is in the best interest of the City of Pahokee; and

**WHEREAS**, the City Commission desires to authorize the execution of the Agreement attached hereto as Exhibit "A "with Angela Reyes, LLC.

**NOW THEREFORE, BE RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AS FOLLOWS:**

**Section 1.** Adoption of Representations. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

**Section 2.** Approval and Authorization. The City Commission of the City of Pahokee hereby authorizes execution of an agreement between the City of Pahokee and Angela Reyes, LLC., for the provision of finance services, accounting services and for assistance

with OIG compliance responses, corrective action plans and related services as described in the agreement attached hereto as Exhibit "A," in an amount not to exceed Eighty-Five Thousand Dollars (\$85,000.00) for a term of six months.

**Section 3.** Conflict. All resolutions in conflict herewith are hereby and expressly repealed.

**Section 4.** Effective Date. This Resolution shall be effective immediately upon its passage and adoption.
