

**RESOLUTION 2024 - 13**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AMENDING THE SIGNATORIES FOR VARIOUS BANK ACCOUNTS OF THE CITY OF PAHOKEE AT PNC BANK, N.A; APPROVING MICHAEL E. JACKSON, INTERIM CITY MANAGER, AS AN ADDITIONAL SIGNATORY; REMOVING RODNEY D. LUCAS FROM ALL ACCOUNTS AND AUTHORIZING CITY OFFICIALS TO EXECUTE ALL NECESSARY DOCUMENTS TO COMPORT WITH THIS RESOLUTION AND WITH PNC BANKING REQUIREMENTS; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Pahokee (“City”) recognizes PNC Bank, N.A. as its financial institution; and

**WHEREAS**, Michael E. Jackson, is the City’s Interim City Manager and needs to be added as an additional authorized signatory for all City accounts at PNC Bank, N.A.; and

**WHEREAS**, the current signatories for the City’s banking account are: Tijauna Warner, City Clerk; Mayor Keith W. Babb, Jr.; Joseph R. Martin, Interim Finance Director; and Rodney D. Lucas, former City Manager; and

**WHEREAS**, the City Commission of the City of Pahokee (“City Commission”) desires to add additional signatory, Michael E. Jackson, Interim City Manager to the City’s banking accounts and further remove Rodney D. Lucas from all banking accounts and authorize the execution of all necessary documents to comport with this resolution and with PNC Bank, N.A. banking requirements.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, AS FOLLOWS:**

**SECTION 1.**        Adoption of Representations. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

**SECTION 2.**        Authorization and Approval. The City Commission of the City of Pahokee, Florida hereby authorizes and approves additional signatory, Michael E. Jackson, Interim City Manager, to the City’s banking accounts at PNC Bank, N.A. and further authorizes the removal of Rodney D Lucas, former City Manager, with all other signatories remaining same. The City Commission authorizes the

execution of all necessary documents to comport with this resolution and with PNC Bank, N.A. banking requirements.

**SECTION 3.** Effective Date. This Resolution shall become effective immediately upon passage and adoption.
