Article 1: General Provisions.

Approved by the Planning Commission in December of 2024; sent to Attorney Scott Krob for review; final to be reviewed with the entire update to the Zoning code.

Article 2: Districts and Uses.

Updated Article 2, was sent to Planning Commission on November 18, with the memo outlining remaining issues; workshop held on December 2, 2024, and special meeting on December 4th.

Article 3: General Standards Applicable to All Zone Districts. Sent May 8th; See memo dated May 8th.

Article 4: Special Requirements.

This includes much of what is already in the current code including flood-prone areas, Industrial and Commercial performance standards and perhaps a cluster development provision alternative to the PD.

Article 5: Administration and Procedures.

Article 6: Annexation. Chapter 17.14.040 Adopted, nothing to review adopted- will be renumbered.

Article 7: Definitions. This is typically the last task when updating a code, and should not include any rules, but simply define the terms. This is the last article to draft.
