ORDINANCE NO. 5_-2024

AN ORDINANCE AMENDING THE PALMER LAKE MUNICIPAL CODE BY ADDING chapter 5.06 REGULATING THE USE OF PUBLIC PROPERTY OWNED BY THE TOWN THROUGH THE ADOPTION AND IMPLEMENTATION OF A SPECIAL EVENTS PERMIT SYSTEM FOR SUCH USES

WHEREAS, the Board of Trustees of the Town of Palmer Lake, Colorado, pursuant to Colorado statute and the Palmer Lake Municipal Code, is vested with the authority of administering the affairs of the Town; and

WHEREAS, the Town owns multiple public properties that are or may, under certain conditions, be suitable for special events; and

WHEREAS, the Board of Trustees has determined that in order to protect public property owned by the Town, it is necessary and in the best interest of the public health, safety and welfare to adopt and implement a special events permit system governing the use of Town properties for special events; and

WHEREAS, The Board of Trustees has received, reviewed and considered proposed additions to the Town Code, as set forth in Exhibit A, attached, establishing Chapter 5.06, a system for issuing special events to use Town property; and

WHEREAS, the Board of Trustees has concluded that it is in the best interest of the health, safety and welfare of the Town to adopt Chapter 5.06 regarding special event permits as set forth on Exhibit A, attached and add it to the Town Code.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PALMER LAKE, COLORADO AS FOLLOWS:

- 1. The Palmer Lake Municipal Code is hereby amended by adding Chapter 5.06 Special Event Permits, as set forth in its entirety on Exhibit A, attached.
- 2. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Board of Trustees hereby declares that it would have passed this Ordinance and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

3. Repeal. Existing ordinances or parts of ordinances covering the same matters embraced in this Ordinance are hereby repealed and all ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the effective date of this Ordinance.
