The City of Pleasant Hill solicited bid proposals for the Police Station Renovation project on June 4th, 2025. Newspaper advertisements were made and notice of bid was sent to the Tribune & Times. A pre-bid meeting was held at the Police Station on June 12<sup>th</sup>, 2025 to review the bid requirements. The walkthrough allowed the prospective bidders the opportunity to view the current site. There were sixteen (16) area general contractors in attendance for the pre-bid meeting, and thirty-four (34) area general contractors contacted during the advertising period.

Proposals were received on June 25<sup>th</sup>, 2025. A total of nine (9) sealed submissions were received and opened publicly (Newkirk Novak, Westport Construction, Excel Construction, Straub Construction, Royal Construction, Icon Structures, Monarch Build, Camm Construction, and A.L. Huber). The project team performed a preliminary evaluation of the proposals and compiled a spreadsheet evaluating the overall costs. Interviews were held with the two lowest responding bidders (Camm Construction and Westport Construction)

The project team has performed an evaluation of the bids received and recommends proceeding with awarding Westport Construction Co. for the Police Station Renovation Project for a total project cost of \$718,800. This includes an unforeseen conditions allowance of \$25,000 and acceptance of Alternates 1,2, 3, and 4.
