#### **NEW BUSINESS**

- 3. Discussion of the previous tree removal The Board discussed the process and responsibility regarding a recently removed tree. Public Works Director Dave is awaiting a price quote for an additional tree removal and will present it to the Board at the next meeting. It was clarified that the tree is located on property belonging to the fire department; therefore, their approval is required before any removal can proceed. The Board discussed the possibility of offering reimbursement to the fire department for the work, to avoid further use of staff time, noting that significant time has already been invested by both parties.
- discussion on transparency regarding the clerk election Board discussed that Clerk Miller and her husband filed a lawsuit to have her name added to the ballot, incurring over \$13,000 in legal fees. The court ruled the error was the Clerk's, not the County's, and ordered her to pay the costs.

There is currently no request for reimbursement, and the Village was not named in the lawsuit. Clerk's Millers name was not on early ballots and only added late by court order.

Former County Clerk Pam McCullaugh stated it's the candidate's duty to verify ballot info.
