ORDINANCE NO. 202-02

AN ORDINANCE CORRECTING AN ORDINANCE ADOPTING COMPREHENSIVE PLAN UPDATE OF THE VILLAGE OF POPLAR GROVE

WHEREAS, the Village of Poplar Grove ("Village") is an Illinois municipality organized and operating in accordance with the Illinois Constitution of 1970 and the Illinois Municipal Code (65 ILCS 5/1-1-1, et seq.) ("Code"); and

WHEREAS, the Village Board of Trustees adopted a Comprehensive Plan Update on January 8, 2025 (the "Ordinance"); and,

WHEREAS, the Village Board wishes to correct three scrivener errors that were inadvertently contained in the Ordinance, without repeal of the Ordinance and without delay of its effective date.

BE IT ORDAINED by the President and Board of Trustees of the Village of Poplar Grove, Boone County, Illinois, as follows:

Section 1. <u>Findings</u>. The President and Board of Trustees hereby make the following redline corrections to the Ordinance:

<u>Section 1, Subsection C.</u> The Village contracted with <u>Studio GWA and Redevelopment Research (the "Consultant")</u> for the purpose of studying and preparing updates to the Comprehensive Plan;

Section 4. Filing and Effective Date. The Village Manager, or his designee, is authorized and directed to file notice of the adoption of the Comprehensive Plan in the Office of the Boone Lake County Recorder. The Comprehensive Plan shall become effective upon the expiration of 10 days after the date of filing notice of the adoption of the Comprehensive Plan with the Boone Lake County Recorder.

Section 2. Filing and Effective Date. These revisions are effective retroactively to the date of passage of the Ordinance.

Section 3. All prior Ordinances in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency. Notwithstanding the foregoing, this Ordinance shall not be construed or held to repeal a former ordinance as to any offense committed against such former ordinance or as to any act done, any penalty, forfeiture or punishment so incurred, or any right accrued or claim arising under the former ordinance, or in any way whatsoever to affect any such offense or act so committed or so done, or any penalty, forfeiture or punishment so incurred or any right or claim arising before this Ordinance takes effect, save only that the proceedings thereafter shall conform to the ordinance in force at the time of such proceedings, so far as practicable.

Section 4. <u>Severability</u>. It is hereby declared to be the intention of the Village Board that the several provisions of this ordinance are separable, in accordance with the following:

- A. If any court of competent jurisdiction shall adjudge any provision of this Ordinance to be invalid, such judgment shall not affect any other provision of this Ordinance not specifically included in said judgment; and
- B. If any court of competent jurisdiction shall invalidate the application of any provision of this Ordinance to a particular property, building, or other structure, such judgment shall not affect the application of said provision to any other property, building, or structure not specifically included in said judgment.
