As part of the contract renewal, we would need. To amend some of the contract pricing. All other portions of the contract will remain unchanged.

Several key supplier partners have notified us of recent price increases. These were nationwide increases, not just increases for Bound Tree. The remaining items on the bid will stay at the same pricing. As a result, we are requesting a contract amendment to adjust the contract prices that have been impacted to reflect the direct pass-through of the manufacturer increases that cannot be absorbed.
