# RESOLUTION

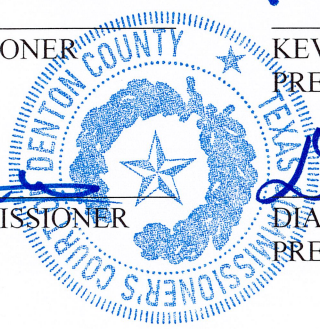
