

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI,
DECLARING THE RESULTS OF THE JUNE 2, 2020, MUNICIPAL ELECTION**

WHEREAS, the City of Republic, Missouri, ("City" or "Republic") is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the official return of the April 7, 2020 held on June 2, 2020, municipal election has been certified to the Republic City Council by the Greene County Clerk and Christian County Clerk and it is desired to declare the results of said election.
