A RESOLUTION OF THE CITY COUNCIL AUTHORIZING EXECUTION OF A SERVICES AGREEMENT WITH AEGIS DIGITALIS FOR ONGOING MAINTENANCE AND SUPPORT OF THE AUTOMATED PROGRAMMING INTERFACE FROM POLICE DEPARTMENT DATA MANAGEMENT SOFTWARE TO PROSECUTING ATTORNEY MANAGEMENT SOFTWARE

WHEREAS, the City of Republic, Missouri, ("City" or "Republic") is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the City of Springfield developed a programming interface capable of transferring data from citations issued by the Springfield Police Department in the law enforcement information management system Niche ("Niche") to the Prosecuting Attorney Management System ("PAMS"); and

WHEREAS, the Republic Police Department (RPD) and City Prosecutor use the same data systems, Niche and PAMS, for the issuance of tickets and filing of tickets with the Court here in the City, respectively;

WHEREAS, In July 2023, the Council authorized an intergovernmental agreement ("IGA") with Springfield to share information that would assist the City in developing its own programming interface to automate the transfer of ticket data from the RPD to the City's Prosecuting Attorney for filing with the court ("City's API"); and

WHEREAS, the City then engaged the services of Aegis Digitalis, a professional software development company ("Aegis"), to develop the City's API, incorporating the code information obtained through the IGA; and

WHEREAS, the development phase of the City's API is now complete, but ongoing maintenance and support of the City's API is vital to ensure its continued functionality and value to the City; and

WHEREAS, staff now seek approval from the Council to enter into an agreement with Aegis for Aegis' provision of ongoing maintenance and support of the City's API; and

WHEREAS, upon review of all materials submitted and presentation by staff, the Council finds it in the best interest of the City to authorize execution of the agreement, as such agreement will ensure the highest value of the City's API in maximizing efficiency and quality, consistent with the City's core values of urgency, boldness and leadership.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:

- Section 1: The City Administrator, or his/her designee, on behalf of the City, is authorized to enter into an agreement with Aegis Digitalis for the provision of maintenance and support services for the City's automated programming interface from the Police Department software to the Prosecuting Attorney's case management software, to be in substantially the same form as that attached hereto and labeled "Attachment 1."
- **Section 2:** The City Administrator, or his/her designee, on behalf of the City, is authorized to take the necessary steps to fully implement this Resolution.
