

**A RESOLUTION OF THE CITY COUNCIL AUTHORIZING EXECUTION OF A GRANT AWARD AGREEMENT
WITH THE FEDERAL HIGHWAY ADMINISTRATION THROUGH THE SAFE STREETS FOR ALL (SS4A) GRANT
PROGRAM TO COMPLETE A TEN-YEAR UPDATE OF THE CITY'S ADA TRANSITION PLAN**

WHEREAS, the City of Republic, Missouri, ("City" and/or "Republic") is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the Federal Highway Administration ("FHWA"), through the United States Department of Transportation ("USDOT"), has awarded the City of Republic \$240,000 as part of its Safe Streets for All (SS4A) grant program, for the purpose of helping fund needed updates to the City's 2016 ADA Transition Plan and Sidewalk Inventory ("ADA Transition Plan"); and

WHEREAS, the City is required to make a 20% match (of \$60,000), provided all funds are utilized; and

WHEREAS, the City wishes to utilize the funds for engaging a consultant to update the ADA Transition Plan, which will include (but is not necessarily limited to) recommendations for improvements to existing infrastructure and future sidewalk needs based on growth, recommendations for ADA-compliant facilities and identification of gaps in the City's sidewalk infrastructure; and

WHEREAS, the updated ADA Transition Plan will also be incorporated into the Ozarks Transportation Organization's Regional Safety Action Plan, allowing for regional coordination of efforts to promote ADA accessibility and pedestrian safety on a larger scale within the surrounding community.

***NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI,
AS FOLLOWS:***

- Section 1.** The City of Republic's BUILDS Department is authorized to accept the award of \$240,00 from the Federal Highway Administration through the Safe Streets for All (SS4A) grant program, for the purpose of helping fund updates to the City's 2016 ADA Transition Plan and Sidewalk Inventory; and
- Section 2.** The City is hereby authorized to remit the 20% match for the aforementioned award, if/when appropriate, at the cost of \$60,000 to the City; and
- Section 3.** The City Administrator, or his/her designee(s), on behalf of the City, is authorized to take the necessary steps to implement this Resolution.
- Section 4.** This Resolution shall become effective on and after the date of passage and approval as provided by law.
