AN ORDINANCE OF THE CITY COUNCIL APPROVING AMENDMENT OF THE ZONING CLASSIFICATION OF APPROXIMATELY 0.71 ACRES OF REAL PROPERTY LOCATED AT 213, 217, AND 221 NORTH MAIN STREET FROM A NON-DESIGNATED ZONING DISTRICT TO MAIN STREET DISTRICT (MSD)

WHEREAS, the City of Republic, Missouri, ("City" or "Republic") is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

WHEREAS, the City of Republic, as property owner, applied for ("Application") an amendment to the Zoning Code and Official Zoning Map rezoning certain real property consisting of approximately 0.71 total acres located at 213, 217, and 221 North Main Street (the "Property"), from the current zoning designation of Non-Designated Zoning District to Main Street District (MSD); and

WHEREAS, the City set a public hearing on the Application before the Planning and Zoning Commission ("PZ Commission") for November 4, 2024; and

WHEREAS, on October 16, 2024, pursuant to Republic Municipal Code § 405.980, the City published notice of the time and date for the public hearing on the Application in the *Greene County Commonwealth*, a newspaper of general circulation in the City, such notice being at least fifteen (15) days before the public hearing; and

WHEREAS, pursuant to Republic Municipal Code § 405.980, the City gave notice of the public hearing on the Application to the record owners of all properties located within 185 feet of the Property, consistent with the information shown by the Greene County Assessor's Office; and

WHEREAS, the PZ Commission conducted the public hearing on November 4, 2024, at which all interested persons and entities were afforded the opportunity to present evidence or statement, and after which the PZ Commission rendered written findings of fact and submitted those along with its recommendations to the Council; and

WHEREAS, the PZ Commission, by a vote of 5 Ayes to 0 Nays, recommended approval of the Application; and

WHEREAS, the Application was submitted to the City Council for first read at its regular meeting on November 5, 2024 and second read at its regular meeting on November 19, 2024, after which the Council voted to approve the Application and amend the Zoning Code accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:

Section 1:

The Zoning Code and Official Zoning Map are hereby amended to reflect the rezoning of the real property consisting of approximately 0.71 total acres located at 213, 217, and 221 North Main Street in Republic, Missouri, more fully described in the legal description herein below, from the zoning classification of a Non-Designated Zoning District to the zoning classification Main Street District (MSD):

All of the North Twenty-eight (28) feet of Lot numbered six (6) in A.S. Groves Addition to the Town of Republic, Missouri; and

All of the north Eighteen (18) Feet of Lot Numbered Five (5); Also one-half interest in and to the brick wall running East and West, located on the North line of the South Twelve (12) Feet of Lot numbered Five (5), also a strip of land, the same being Two (2) Feet wide off the South side of Lot numbered Six (6), all in A.S. Grove's Addition, to the Town of Republic, Greene County, Missouri, according to the recorded deed in Book 2291 and Page 1804 of the County Recorder's Office; and

ALL OF LOT SEVEN (7), in A.S. GROVES ADDITION TO THE TOWN OF REPUBLIC, GREENE COUNTY, MISSOURI, ACCORDING TO THE RECORDED DEED IN BOOK 2729 AND PAGE 2170 OF THE COUNTY RECORDER'S OFFICE; AND

All of Lot Eight in A.S. Grove's Addition to the Town of Republic, Greene County, Missouri, according to the recorded deed in Book 2001 and Page 1884 of the County Recorder's Office; and

All of Lots 9, 10, and 11, in A.S. Grove's Addition, to the Town of Republic, Greene County, Missouri, according to the recorded deed in Book 1642 and Page 1449 of the County Recorder's Office.

- Section 2: In all other aspects other than those herein amended, modified, or changed, the Zoning Code and Official Zoning Map shall remain the same and continue in full force and effect.
- **Section 3**: The WHEREAS clauses above are specifically incorporated herein by reference.
- **Section 4**: The provisions of this Ordinance are severable and if any provision hereof is declared invalid, unconstitutional, or unenforceable, such determination shall not affect the validity of the remainder of this Ordinance.
- **Section 5:** This Ordinance shall take effect and be in force from and after its passage as provided by law.
