A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE CITY TO ENGAGE COOK, FLATT & STROBEL ENGINEERS, P.A. FOR PROVISION OF ENGINEERING DESIGN SERVICES ON THE COMMERCIAL AVENUE WIDENING PROJECT

WHEREAS, the City of Republic, Missouri ("City" or "Republic") is a municipal corporation and Charter City located in Greene County, Missouri, being duly organized and existing under the laws of the State of Missouri; and

WHEREAS, on or about October 21, 2024, the City published a Request for Proposals (RFP#24-004) ("RFP") for engineering design services in connection with the widening of Commercial Avenue widening ("the Project"); and

WHEREAS, the City received one (1) proposal ("Proposal") in response to the RFP from Cook, Flatt & Strobel Engineers, P.A. ("CFS Engineers"); and

WHEREAS, upon evaluation of the Proposal, reviewing staff members determined the Proposal meets the qualifications and needs for the Project, as set forth in the RFP; and

WHEREAS, staff now request the Council's authorization to proceed with the Project by engaging the services of CSW Engineers at the Proposal cost of \$77,098, and pursuant to an agreement containing terms and conditions consistent with those set forth in the RFP; and

WHEREAS, having reviewed all pertinent materials provided and having heard presentation by City staff, the City Council finds it in the City's best interest to authorize the engagement of CSW Engineers for provision of the requested engineering design services, pursuant to an agreement containing terms and conditions consistent with those set forth in the City's RFP.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:

- The City Administrator and/or his designee, on behalf of the City, is authorized to enter into a services agreement with Cook, Flatt & Strobel Engineers, P.A. for provision of the engineering design services referenced herein and as set forth in the Proposal, attached hereto and labeled **Exhibit A**, said agreement to contain terms and conditions consistent with those set forth in the RFP, attached hereto and labeled **Exhibit B**.
- **Section 2.** The cost to the City of the services authorized in this Resolution shall not exceed the total sum of \$80,000 without further, separate authorization from Council.
- **Section 3.** The City Administrator, or his designee(s), on behalf of the City, is authorized to take other reasonable, necessary steps to implement this Resolution.
- **Section 4.** The whereas clauses are specifically incorporated herein by reference.
- **Section 5.** This Resolution shall take effect after passage as provided by law.
