

**AN ORDINANCE OF THE CITY COUNCIL VACATING APPROXIMATELY SIX THOUSAND THIRTY-FIVE (6,035) SQUARE FEET OF RIGHT-OF-WAY LOCATED BETWEEN THE COMMON AREA AND LOT 1 OF MASON RIDGE PHASE I (VACA 25-007)**

**WHEREAS**, the City of Republic, Missouri, (“City” or “Republic”) is a municipal corporation and Charter City located in Greene County, Missouri, being duly created, organized, and existing under the laws of the State of Missouri; and

**WHEREAS**, the City has received a request for the vacation of approximately 6,035 square feet of right of way located between the Common Area and Lot 1 of the Mason Ridge Phase I Subdivision (“Proposed Vacated Area”); and

**WHEREAS**, Mason Ridge LLC (“Applicants”) submitted an application to vacate the Proposed Vacated Area (“Application”) to the Planning and Zoning Commission (“P&Z Commission”), which then set a public hearing on the Application for July 14, 2025; and

**WHEREAS**, on June 25, 2025, at least fifteen (15) days before the public hearing, the City published notice of the time and date of the public hearing in the *Greene County Commonwealth*, a newspaper of general circulation in the City; and

**WHEREAS**, the City gave notice of the public hearing to the record owners of all properties within 185 feet of the Proposed Vacated Area, including all those adjacent to the Proposed Vacated Area; and

**WHEREAS**, the P&Z Commission conducted the public hearing on July 14, 2025, at which all interested parties were afforded the opportunity to present evidence or statement; and

**WHEREAS**, the P&Z Commission, by a vote of 6 Ayes to 0 Nays, recommended approval of the Application, and provided such recommendation along with its written findings of fact to the Council; and

**WHEREAS**, having now reviewed the Application upon first and second read at its regular meeting on July 15, 2025 in accord with the provisions of City Charter Section 3.10(f), the Council finds all requirements for the Application are met and approves vacation of the Proposed Vacated Area as requested in the Application.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF REPUBLIC, MISSOURI, AS FOLLOWS:**

**Section 1:** The right of way between the common area and Lot 1 of the Mason Ridge Phase 1 Subdivision, more fully described in the Legal Description contained herein below, is hereby vacated, and the same shall revert to the affected owner(s) in the same proportion(s) as it was originally taken.

A PORTION OF WILL STREET LOCATED IN MASON RIDGE PHASE 1, A SUBDIVISION IN THE NORTHEAST QUARTER (NE¼) OF SECTION 28, TOWNSHIP 28 NORTH, RANGE 23 WEST OF THE 5TH P.M. IN THE CITY OF REPUBLIC, GREENE COUNTY, MISSOURI, SAID PORTION OF STREET BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF LOT 1 OF SAID MASON

RIDGE PHASE 1, THENCE S69°06'01"E, ALONG THE SOUTH LINE OF SAID LOT 1, 98.51 FEET; THENCE EASTERLY, CONTINUING ALONG SAID SOUTH LINE OF LOT 1, ALONG A CURVE TO THE LEFT, AN ARC LENGTH OF 11.52 FEET, WITH A RADIUS OF 25.00 FEET, AND A CHORD BEARING AND DISTANCE OF S82°18'18"E, 11.42 FEET; THENCE S00°31'33"E, 56.51 FEET TO A POINT ON THE SOUTH LINE OF SAID WILL STREET (AS IT NOW EXISTS); THENCE N69°06'01"W, ALONG SAID CURRENT SOUTH RIGHT OF WAY LINE, 130.27 FEET; THENCE N20°53'59"E, 50.00 FEET TO THE POINT OF BEGINNING. BEARINGS ARE BASED ON THE MISSOURI COORDINATE SYSTEM OF 1983, CENTRAL ZONE. SAID DESCRIPTION IS SHOWN ON JOB No. 250513 BY O&M SURVEYING, LLC, LC-2022004477 AND IS INCORPORATED FULLY HEREIN BY REFERENCE.

**Section 2:** The City Clerk is hereby directed to record a certified copy of this Ordinance with the Recorder of Deeds for Greene County, Missouri.

**Section 3:** The whereas clauses are hereby specifically incorporated herein by reference.

**Section 4:** The provisions of this Ordinance are severable, and if any provision hereof is declared invalid, unconstitutional, or unenforceable, such determination shall not affect the validity of the remainder of this Ordinance.

**Section 5:** This Ordinance shall take effect and be in force from and after its passage as provided by law.
